GLOBALISATION AND GOVERNANCE

While it might have been viable for states to isolate themselves from international politics in the nineteenth century, the intensity of economic and social globalisation in the twenty-first century has made this choice impossible. The contemporary world is an international world – a world of collective security systems and collective trade agreements.

What does this mean for the sovereign state and 'its' international legal order? Two alternative approaches to the problem of governance in the era of globalisation developed in the twentieth century: universal internationalism and regional supranationalism. The first approaches collective action problems from the perspective of the sovereign equality of all states; yet the consent requirement here typically settles for a governmental minimalism in which the unanimity rule translates into a 'tyranny against the majority'. A second approach to transnational governance has tried to remedy this by re-establishing majoritarian governmental structures on the regional scale. This regional approach promised to reduce collective action problems, and it did so by inviting states to share their internal sovereignty within a broader supranational 'union' of states.

This collection of essays aims to analyse – and contrast – the two types of normative and decisional solutions that have emerged as responses to the 'international' problems within our globalised world.
