Having started as the 'Europe of the Six' in a very specific industrial sector, the Union today has 28 Member States and acts within almost all areas of social life. European law has come to influence almost all fields of national law, including administrative law, constitutional law, contract law, criminal law and even tort law; and it has also played a major role in the development of competition law, environmental law and employment law.

What is the European Union? How does it work, and how does it produce European law? Written with exceptional clarity, *European Constitutional Law* offers a classic textbook for students and practitioners of European law alike. Using a clear framework, it guides readers through all the core constitutional topics of EU law. Extracts from classic case law are complemented with extensive and critical discussion of the theoretical and practical aspects of the European Union and its law. Chapters are enriched with more than fifty colour figures and tables, which clarify complex topics and illustrate relationships and processes. Suggestions for further reading direct students to significant pieces of academic literature for deeper self-study, and a companion website with full 'Lisbonised' versions of the cases cited in the text completes the learning package.
