The regulation of business in the global economy poses one of the main challenges for governance, as illustrated by the dynamic scholarly and policy debates about the UN Guiding Principles on Business and Human Rights and a possible international treaty on the matter. This book takes on the conceptual and legal underpinnings of global governance approaches to business and human rights, with an emphasis on the Guiding Principles (GPs) and attention to the current treaty process. Analyses of the GPs have tended to focus on their static dimension, such as the standards they include, rather than on their capacity to change, to push the development of new norms, and practices that might go beyond the initial content of the GPs and improve corporate compliance with human rights. This book engages both the static and dynamic dimensions of the GPs, and considers the issue through the eyes of scholars and practitioners from different parts of the world.

César Rodríguez-Garavito is Executive Director of the Center for Law, Justice, and Society (Dejusticia), and director of the Global Justice and Human Rights program at the University of the Andes (Colombia). He is the founding director of the Human Rights Lab and codirector of the Global School on Socioeconomic Rights. He writes a weekly op-ed for the Colombian newspaper El Espectador.

Larry Catá Backer is the W. Richard and Mary Eshelman Faculty Scholar and professor of law and international affairs at Pennsylvania State University. His research focuses on governance-related issues of globalization and the constitutional theories of public and private governance, with a focus on institutional frameworks for public-private law governance systems. Recent work focuses on issues of corporate social responsibility, mixed regulatory systems and regulatory governance, the emerging problems of polycentricity where multiple systems might be simultaneously applied to a single issue or event, and problems of translation between Western and Marxist-Leninist (especially Chinese) constitutional systems. He teaches courses in corporate law, transnational law, and international organizations. His publications include Lawyers Making Meaning (2013) and Signs in Law, A Source Book (2014) (both with Jan M. Broekman), casebooks, Elements of Law and the U.S: Legal System (2017), Law and Religion (2015, with Frank Ravitch), Comparative Corporate Law (2002), Harmonizing Law in an Era of Globalization (editor, 2007), and a number of articles and contributions to published collections of essays. His work, especially on Chinese constitutional law and corporate social responsibility, has been translated into Chinese.

Louis Bickford is the CEO of MEMRIA, a social enterprise which develops partnerships with organizations to collect, analyze, and circulate narrative accounts of past violence with the aim of strengthening human rights. From 2012– 2017, he managed the Global Human Rights program at the Ford Foundation. Before that, he worked at the International Centre for Transitional Justice (ICTJ), where he was among the founding staff members and where he developed work on memory and accountability in countries as diverse as Bosnia, Cambodia, Canada, Ghana, Morocco, and Peru, among others. He later worked at RFK Human Rights as a member of the executive leadership team, and as the director of the European office. He has consulted with various national and international institutions including the United Nations and various philanthropic foundations in every world region. Surva Deva is an associate professor at the School of Law of the City University of Hong Kong, and a member of the UN Working Group on Business and Human Rights. Deva's primary research interests lie in business and human rights, India-China constitutional law, and sustainable development. He has published extensively in these areas, and has advised UN bodies, states, multinational corporations, and civil society organizations on issues concerning business and human rights. Bonita Meyersfeld is a human rights lawyer and academic. She is the director of the Centre for Applied Legal Studies and an associate professor at Wits Law School. He holds a PhD and an MS (sociology) from University of Wisconsin-Madison, an MA from NYU's Institute for Law and Society, an MA (Philosophy) from the National University of Colombia, and a JD from University of the Andes. His recent publications include Radical Deprivation on Trial: The Impact of Judicial Activism on Socioeconomic Rights in the Global South (CUP, coauthor), Compliance with Socioeconomic Rights Judgments (CUP, coed.), and "The Future of Human Rights: From Gatekeeping to Symbiosis" (Sur Journal).
