**Alejandra Boni** is a Professor at Polytechnic University of Valencia (Spain), and Deputy Director of the INGENIO Research Institute (CSIC-UPV). She is Extraordinary Professor of the University of the Free State, South Africa and former Vice-President of the International Development Ethics Association. Her research analyzes educational processes using the capability approach and development education. **Flavio Comim** is an associate professor at Ramon Llull University in Barcelona and an affiliated lecturer in Land Economy and Development Studies at the University of Cambridge as well as a Visiting Fellow at St. Edmund’s College. He has worked as Senior Economist for UNDP and as a consultant for UNEP, FAO, WHO, and UNESCO. **Adela Cortina** is Professor of Ethics and Political Philosophy at the University of Valencia (Spain), where she received her doctorate in Philosophy in 1976. Soon thereafter she was awarded a grant to work at the University of Frankfurt with Karl-Otto Apel and Jürgen Habermas, the founders of discourse ethics. She was the first woman to be made a member of the Spanish Royal Academy of Moral and Political Science and holds numerous directorships and advisory positions in and out of academia. She holds five honorary doctorates and has been awarded medals from three other universities, as well as numerous international prizes. She is a member of the board of the International Development Ethics Association and of the Human Development and Capability Association, the Societas Ethica, and of the International Network of Discourse Ethics. Her most recent books include *Cordial Justice* (2010); *Neuroethics and Neuropolitics* (2012); *The Comares Guide to Practical Neurophilosophy* (2012, coord.); and *What Is Ethics really for?* (2013).

**David A. Crocker** is Research Professor and Director of the University of Maryland School of Public Policy's international development specialization and Founding President of the International Development Ethics Association. He specializes in international development ethics, sociopolitical philosophy, transitional justice, democracy, and democratization. A Yale graduate (M.Div., MA, PhD), Dr. Crocker taught philosophy for twenty-five years at Colorado State University, where he established one of the world's first courses in ethics and international development. His most recent publications are *Ethics of Global Development: Agency, Capability, and Deliberative Democracy*, "Development and Global Ethics: Five Foci for the Future," and "Obstáculos para la reconciliación en el Perú: un análisis ético." In 2010, Dr. Crocker received the Landmark Award "for exceptional long-term achievements in support of international life at the University of Maryland." He has directed seven UMD study-abroad trips (Morocco, Peru, and Ethiopia) and directs KEMS (Kids Excelling in Math and Science), an after-school enrichment program for middle-schoolers.

**Nigel Dower** is Honorary Senior Lecturer in Philosophy and Associate at the Centre for Global Development at the University of Aberdeen where he taught for thirty-seven years, with an interruption to teach for three years in Zimbabwe. His main research interests are in the ethics and philosophy of development, environment, and international relations. He is the author of *World Poverty: Challenge and Response* (1983), *World Ethics: The New Agenda* (1998, 2nd ed. 2007), *An Introduction to Global Citizenship* (2003), and *The Ethics of War and Peace* (2009) as well as coeditor of *Global Citizenship: A Critical Reader* (with John Williams, 2002). He was the second President of the International Development Ethics Association.

**Jay Drydyk** is Professor of Philosophy at Carleton University, Ottawa (Canada), past President of the International Development Ethics Association, and Fellow of the Human Development and Capabilities Association. His published articles and chapters concern development ethics, human rights, the capabilities approach, and social and global justice. He is coauthor of *Displacement by Development: Ethics, Rights, and Responsibilities* (2011) and coeditor of *Theorizing Justice* (with Krushil Watene, 2016) and *The Routledge Handbook of Development Ethics* (with Lori Keleher, 2019).

**Alexandre Apsan Frediani** is a senior lecturer in Community-Led Development in the Global South and Course Director, MSc Social Development Practice, in the Bartlett Development Planning Unit of University College London. He is a development planner specializing in squatter settlement upgrading policies and participatory approaches to development. His areas of expertise include human development, housing, urban development, participation, and Amartya Sen's capability approach. He is coeditor of *The Capability Approach, Empowerment and Participation: Concepts, Methods and Applications* (with David A. Clark and Mario Biggeri, 2017).

**Des Gasper** is a professor at the International Institute of Social Studies in The Hague, a graduate school of international development studies within Erasmus University Rotterdam, Netherlands. After studies in Britain in economics, international development, and policy analysis, he worked through the 1980s in Africa as a government planner and university lecturer. **Serene J. Khader** is a moral and political philosopher working primarily on feminist issues in global justice. His recent research in development ethics concerns multinational corporate responsibility in developing nations, particularly in cases of resource extraction. He also focuses on vulnerability and finance, inquiring into for-profit credit schemes directed at the poor within less developed as well as more developed nations. His philosophical writing extends beyond these areas also to globalization, to business ethics, and to history and philosophy of science and culture.

**Gonzalo Salas** is Assistant Professor at Institute of Economics, Faculty of Science, Economics and of Administration, University of the Republic (Uruguay). His topics of interest are economic inequality, poverty, and public policy. His recent research focuses on child development and parenting, assessing the role of cognitive and noncognitive skills.

**Chloe Schwenke** is the Interim Executive Director of the Association of Writers & Writing Programs (AWP) in Riverdale Park, Maryland, and she is also a member of the adjunct faculty at the School of Public Policy at the University of Maryland.
