## CHAPTER XI. THE BUILDING OF THE MANSION HOUSE

Dance's remuneration and duties. Proposals for removing the paving of the Stocks Market, digging, masons' and carpenters' work. Robert Taylor a mason. Members of the Court of Common Council allowed to tender. *Gentleman's Magazine* of 7th June, 1738, and the scandal of not accepting the lowest tender. Printer and publisher of the *General Evening Post* attend the Court of Aldermen. A pamphlet of 1738 on the scandal. Many letters in the press. "A Guide to St Thomas's Day," "City Corruption and Mal-Administration," etc. Contractors form a ring. Report of Committee on the scandal and reform proposed. A sewer in Bearbinder Lane. Piling and planking for foundations. Tenders for smiths' and plumbers' work. More members of the Court of Common Council become contractors. The Foundation Stone, the ceremony, coins deposited. Junction of Walbrook and the Poultry found too narrow for traffic: purchase of the Duke of Bedford's property. Extra allowance to contractors on account of "the rupture with Spain and France." The staircases. Finishings generally. Carving. Freeman and foreigners. Parish distress on account of buildings removed. Sanitary arrangements. Objections to the proposed sewer on the south side of the building. The proposed stable and coach house in the Mansion House not to be carried out. Lighting of the exterior. The Lord Mayor, Sir Crisp Gascoigne, enters into residence. Taxes in 1753. Poor Rate, etc. Dance's account. Egyptian Hall not completed. Assessment in 1755. Allowance to the Lord Mayor with reference to maintenance of furniture, etc. West entrance to be made. Proposed coach house and stable. Egyptian Hall used at Easter, 1757. Chandeliers for the Dancing Gallery and Egyptian Hall. Site near Leadenhall Market considered for stable buildings. Grocers' Company lend their stables to the Lord Mayor. Blackwell Hall and Dowgate Hill considered for a stable site: screen to be formed between the Cortile and the Vestibule. Portico on the west side. Sanitary arrangements. Insurance against fire considered unnecessary. Damage during the Gordon riots. Covered way across the Cortile. Dry rot in the roof of the Egyptian Hall. Porch on the west front to be enlarged. Sale of materials from the roof of the Egyptian Hall. Estimate for new roof to the Egyptian Hall and Ball Room and for covering in the Cortile. The Grand Staircase to be removed and two rooms formed. Gallery to Egyptian Hall to be removed. Paving to be removed and a wood floor fixed in the Egyptian Hall. Alterations to windows of the Egyptian Hall. Lighting by oil lamps. ## CHAPTER XII. WORK DURING THE NINETEENTH CENTURY

Design to finish the Saloon in 1801. Petition of the Rector of St Mary Woolchurch-haw and St Mary Woolnoth, as evening lecturer. Alterations and formation of the Justice Room.
