Chapter I. RELIGION IN THE HOME, pp. 1–43

Three funerals—Pusey, Lowder, Simeon. S.'s ecclesiastical statesmanship. Use of printed sources. The theme of all Church History. S.'s home not 'a religious home': daily services—the High Church tradition: S. introduces family worship: family prayers—the Puritan tradition: Evangelical clergy admit their parishioners: prayer-meetings or conventicles: importance of the revival of family worship in the history of the Evangelical Movement: the High Church and the Evangelical tradition compared—liturgical and non-liturgical. S. 'finds trials in his own family': death of his eldest brother: S. prepares to leave Cambridge: his father obdurately prejudiced against 'Methodism': S. presented to Holy Trinity, Cambridge: conversion of his elder brothers, Edward and John: triumphs of the Evangelical Revival among 'the public school class'.

Chapter II. RELIGION IN THE SCHOOL, pp. 45–96

Condition of the public schools: S. as a boy at Eton (1767–79): the Montem of 1778: S. on the state of religion and morals at Eton during his school days. The archetypal controversy regarding Public School Religion (1799–1802), concerned with the disproportion of Classical to religious instruction: Jones of Nayland, *Considerations on the Religious Worship of the Heathens* (1799): Dr Vincent, Head Master of Westminster, replies privately: Dr Rennell's Charity Sermon (1799): Dr Vincent remonstrates: the Bishop of Meath's Charity Sermon (1801): Dr Vincent publishes his *Defence of Public Education* (1802): Dr Vincent is rewarded with the Deanery of Westminster, to which he adds a country rectory. But how far was Eton covered by his *Defence*? Religious observance and religious instruction at Eton in 1766: gradual reforms (1809–37): Confirmation and Holy Communion in public schools: Sermons. Rowland Hill at Eton (1753–64): his conversion (1762): forms 'a religious society'. S. seriously impressed by the Fast Day of 1776. The foundation of the Newcastle Scholarship (1829) establishes divinity as a

Chapter III. RELIGION IN THE UNIVERSITY, pp. 97–147

Inadequacy of the curriculum in the two Universities, regarded as theological seminaries: Pusey's criticisms (1833): demand for reform: Professor Marsh (1792): Bishop Porteus (1767). Heterodoxy at Cambridge: Professor Watson: the Subscription Controversy: Socinianism and Latitudinarianism: Professor Hey: 'Clergymen's Doubts': Porson: Tyrwhitt, Jebb, Palmer, Frend: Robert Robinson. Compulsory Chapel: 'necessary to have some kind of muster-roll': undergraduate irreverence: the Fellows conspicuous by their absence. The Holy Communion: some measure of compulsion: this the instrument of S.'s conversion (1779): 'the Terminal Sacrament': details of collegiate use. Revival of the Subscription Controversy (admission of Dissenters to degrees) in 1833: Professor Turton's opposition: Thirlwall's *Letter to Turton* (1834) denounces compulsory chapel: Whewell replies: Thirlwall resigns his Assistant Tutorship under protest. Undergraduate behaviour in Chapel much improved: but the Fellows still negligent in their attendance: Trinity College, Society for the Prevention of Cruelty to Undergraduates (1838). S. and services in King's College Chapel. Few sermons in College Chapels. Attendance at the University Sermon generally very sparse: some popular preachers—Scott, Marsh, S.: improved attendance in the early nineteenth century: favourite preachers: 'Scraping'. Attendance of undergraduates at parish churches: the Evangelical strongholds: contrast with earlier period: Dr Ogden. S., converted, seeks a spiritual home and a spiritual father: this the explanation of much of his own subsequent activity. S. attends St Edward's: Christopher Atkinson introduces him to John Venn: S. meets Henry Venn, Rector of Yelling (1782): so terminates his quest.

Academic Clergy: Pastor Moritz at Oxford (1782): Sunday-evening Clubs: pastoral ministrations: Bishop Keene's Charge of 1771: Farmer, Unwin, Bennet, Venn, Thomas Robinson, Henry Martyn. John Berridge, Fellow of Clare: Curate of Stapleford (1749): Vicar of Everton (1755): his conversion (1757). The Everton Revival (1758–59): visits from Whitefield and John Wesley: 'violent outward symptoms': Berridge joined by Hicks of Wrestlingworth: open-air preaching: eye-witness narratives: scenes at Everton: Berridge and Hicks itinerate: visit from Lady Huntingdon's chaplains: scene at Stapleford: Dr John Green is scornful: further visits from Wesley:

Berridge preaches before the University: forms acquaintance with Rowland Hill and other undergraduates (1764–71): Lady Huntingdon introduces Berridge to ‘the religious circles of the metropolis’. Berridge’s mode of living and of preaching. The Calvinistic Controversy: Berridge’s controversy with Fletcher (1773–74): relations with Wesley strained since 1760: Berridge becomes a Calvinist: Fletcher’s tribute to him: reconciliation (1776): Berridge’s final views on religious controversy. Church-work at Everton: Venn comes to Yelling (1771): John Venn introduces S. to Berridge (1782). Berridge in old age: eccentricities: failing powers: death (1793): S. preaches his funeral sermon: epitaph.

Chapter V. CADOGAN OF READING, pp. 201–247

S. a purchaser of livings (1836): his object: the problem of Continuity. The Rev. the Hon. W. B. Cadogan appointed Vicar of St Giles’, Reading (1774), prior to his ordination: and then also Rector of St Luke’s, Chelsea (1775). His predecessor at St Giles’, the Rev. William Talbot. Cadogan’s appointment resented: he dismisses his predecessor’s curate, the Rev. John Hallward. Hallward’s previous history: his association with the Six Students of St Edmund Hall, Oxford: visit from Rowland Hill: Whitefield’s interest: expulsion of the Six Students (1768): a war of pamphlets. Hallward’s subsequent career and death (1826). Dispersal of Mr Talbot’s congregation: Lady Huntingdon opens a Chapel: others join the Baptists: Cadogan criticised by members of his congregation: Hallward’s tribute to Mr Talbot’s memory: Mrs Talbot opens her house for religious exercises. Cadogan retires to Chelsea: shows energy and zeal: his popularity wanes: he returns to Reading. Cadogan’s early history: Westminster and Christ Church: religious impressions: internal conflict: friendship with Mrs Talbot: altered religious sentiments: psychological reaction: illness: marriage. Cadogan an exemplary parish priest at Chelsea and Reading. The Evangelicals attached too much importance to the ministry of preaching: Cadogan’s letter to the Bishop of London. Signs of trouble in store at Reading: death of Cadogan (1797): S. preaches his funeral sermon: Cadogan succeeded at Reading by the Rev. Joseph Eyre: his congregation dissipated by successive schisms (1797–1839). Erasmus Middleton, Cadogan’s curate at Chelsea: one of the Six Students: obliged to leave by Cadogan’s successor, the Rev. Charles Sturges. Difficulty of maintaining continuity: Wallingford (Pentycross): Berridge’s letter to Lady Huntingdon: William Hey: Huddersfield (Venn). Other problems, such as recruitment and training, ordinations, presentations, secondary to this problem of securing continuity of teaching. Purchase of livings the solution: John and Henry Thornton: the Simeon Trust: dangers of this policy.

Chapter VI. SIMEON AND CHURCH ORDER, pp. 249–312

The problem of Church Order. Undenominationalism: Watson, Berridge. Distinction drawn between ‘gospel labourers’ and the main body of the clergy. Danger of secession. Itinerancy the crux: divergence between

Evangelicals (Hervey, Walker, Adams, S.) and Methodists (Berridge, Wesley). Larger liberty issues in censorious exclusiveness: Berridge scandalised by the language of the Catechism. Berridge's itinerant ministry: difficulty in finding hard-working unmarried curates: efforts made to curb his activities: his interview with Bishop Thomas: preaching the Gospel 'to every creature': co-operation with Dissenters: Berridge's lay-preachers. Critical estimate of Berridge by S. Crisis at Bluntisham (1785): S.'s relations with Berridge and with Venn: Coxe Feary of Bluntisham: Feary attends Venn's ministry: Venn preaches in a barn at Bluntisham: Berridge's letter to Thornton: S. preaches at Bluntisham: Berridge's instructions to S.; Venn dissuades S. from irregularity: significance of this decision: Feary establishes a Dissenting church at Bluntisham: S. inculcates regularity on his young men: his views respected by Rowland Hill. S.'s religious society: irregularity of this: he consults Wesley: his religious societies get out of hand: serious trouble (1811): S.'s considered judgment, value of such societies as a bulwark against Dissent: he utilises laymen as parochial visitors. S. on Dissent: its weaknesses and evils: his devotion to the Prayer Book: services rendered by Dissent: 'but be cautious of separation': S. at a Dissenting prayer-meeting: subsidises Johnny Stittle: limits of co-operation: cordial relations with local Non-conformist ministers: rebuked by Robert Hall (1795), who calls S. a 'political preacher': the Evangelicals commonly High Tories. Altered character of Evangelicalism after S.'s death: S.'s churchmanship. S. in Scotland: comparison with Rowland Hill: S. and the Church of Scotland: he justifies his conduct on the principle of Church Order: how the present position has developed: George IV in Edinburgh (1822): Dr Hook's sermon, 'Hear the Church' (1838): Queen Victoria and the Prince Consort visit Scotland (1842): the Prince Consort's influence: Disraeli's comments (1850): the Queen rebukes Archbishop Longley (1866): receives communion at Crathie church (1873). But in 1798 the General Assembly excluded Anglican clergy from the pulpits of the Kirk: Rowland Hill's comment. Conclusion: S.'s solution of the problems of Continuity and Church Order decisive for the future: kept the Evangelicals in the Church of England: his humility.
