CHAPTER I.

ECONOMIC CONDITIONS. (pp. 17—99.)

Error of considering as a national trait what is merely the characteristic of a certain grade of evolution.

I. *System of Taxation*, pp. 18—37. Direct taxes. *Ne onus inhaereat fundo*. Amount of taxes. The *portae*. The *dica*. Croatia's privilege. Scarcity of coined money. Difference between the North-West counties and the Lowlands (Alföld). The mountain districts are industrial, but their wealth is on the decline. The population of the Alföld; its wealth and the amount of its taxes are fast increasing. The various counties in arrears with their payment of taxes. *Regulamentum militare* and the supply of food and fodder. Decadence of North-West districts. Preference given by the Government to Austrian manufactures. Hungarian industry and mining on the decline. The counties with a Magyar population on the increase, the German and Slovak populations relatively on the decline. This change is natural and not the consequence of a design. The meaning of nationality in the eighteenth century. Distribution of the estates of the Crown, of the Church, of the magnates and the gentry in the different districts. The districts of the Magyar gentry rising in importance.

II. *Customs Duties*, pp. 37—46. Commerce disturbed by the period of the wars. Saltpetre. Cattle-driving. The *commissio in oeconomicis*. Commercial policy since 1723. Austrian commercial oppression. Its geographical and historical causes. Austrian tariffs. Opposition in the Parliament and elsewhere. Obstacles to the exportation of Hungarian wines. Commercial treaties damaging to Hungary.

III. *Agriculture and Cattle-breeding*, pp. 46—61. Colonial features in Hungary. Exportation of cattle is the chief staple. Importance of the *latifundia*. Struggle between pasture and agriculture. System of cultivation, three fields and two fields. Primitive character of the farming. Exportation of dairy and garden produce and of fowls. Sericulture. Obstacles in the way of its advance.

IV. *Industry and Commerce*, pp. 61—94. Comparison with England and its colonies. Factories and domestic industry. Scarcity of workmen. Chief articles of industry. The Austrian Government hostile to Hungarian industries. Guilds and their influence. Greek merchants. Fairs; Debreczen, Pest. Acquisition of Fiume and opening for Hungarian maritime trade. School of navigation. Count Benyovszky's projects. Tobacco, preserved meat. Attempts to improve the navigation on the rivers. Resistance of the counties. Poems of Baron Orczi on commerce and luxury. Weirs and sluices. Bad roads. Mail-coaches. Hawkers. Joseph II's judgment on Austrian commerce. "Active" balance. The figures of the returns are not trustworthy.

V. *Conclusion*, pp. 94—99. Hungarian industry in decay, Austrian fast developing. Hungary is treated as a colony, though only one part of it was new territory; the other part was a rival to Austrian manufacture and agriculture, and therefore subjected to this treatment by the Emperor Joseph II.

CHAPTER II.

THE SOCIAL SYSTEM. (pp. 100—195.)

The medieval State and Joseph II, pp. 100—102.

I. *The Nobility*, pp. 102—111. Based on conquest. Foreign elements. Croatian nobles. *Indigenae*. Chief privileges of nobles. Different from the French and English nobility. *Armalistae*. *Banderia*. Hereditary magnates. Their services against the Turk. Lack of a national dynasty and of a national *bourgeoisie*. The Holy Crown. Exemption of the nobles from taxation.

II. pp. 112—127. Increase of the estates and of the wealth of the magnates. Their dignities and offices. Count Palatine. Lord Chief Justice. Ban of Croatia. Chancellor. All are members of Parliament. *Főispán's* (high sheriffs). Signs of decadence. Revolts punished by law. Beginnings of an aristocracy of office. The magnates at the Court. Their luxury, debts. The Court at Pozsony. New manners. Foreign culture. Tendency of magnates to become estranged from the national feeling.

III. *The Gentry*, pp. 127—148. The gentry economically independent both of magnates and Court. Influence of Protestantism. Cessation of military service, Acts of 1715 and 1723. Administration of the counties. The *táblabíró*. Importance of

the county courts. Hungary becomes the nation of lawyers. The gentry the ideal of patriotic writers. Francis Kazinczy on them. Money and time have no value for the *táblabíró*. Their influence, their culture, their home life. Women and children. Patriotism. The *congregatio* or county assembly. County elections, their abuses. Other abuses. Cruelty in inflicting punishments, example in the county of Hont. Relation of the high sheriff (*foispán*) to the county. Joseph II's struggle against the counties.

IV. *The Bourgeoisie and the Royal Free Boroughs*, pp. 148—170. Abuses and corruptions of the town councils. Embezzlement and malversation. The citizens are, for the most part, Germans or strangers. Their privileges. The burgess franchise or privilege of citizenship. The town councils (*magistratus*). The *tribunus plebis*. Dependence upon the Royal Chamber. Oppression of journeymen. Fees of citizenship. Counties declare for free industry and against the guild system in the towns. The *patricii* in the towns. Poverty of the towns. Nobles in the towns (pp. 156—159). Oppression of Greek merchants. The Lutheran intellectual class in the towns. Representation of the towns in Parliament. Sympathies of the towns with Austria. "Town and gown." The medieval towns an exotic plant on Hungarian soil. Small number of their population. The Towns actually pay no more taxes than the peasants. Transitory classes. *Armalistae*; nobles with one session. Jász-Kún districts, i.e. Jazygia and Cumania. The "Hajdú" towns. Their decline in importance during the eighteenth century.

V. *The Peasants and Serfs*, pp. 170—195. The pillars of society. Peasant revolt in 1514. The right of migration restored (1547) and abolished (1715–23). Burdens of the serf. Sogage. The serfs must seek justice in the courts, over which their feudal superiors presided. *Jus gladii*. The position of the serfs better than that of those in France and Germany. Protection of serfs. The poetic and sentimental view of the peasant as expressed by Baron Orczi and Bessenyei. Complaints and wishes of the peasants. The peasants still incapable of maintaining religious convictions and nationality without assistance. Their political creed before 1711. Their resignation. Particular grievances—the burdens of sogage. They seek protection from the Court of Vienna. The *Urbarium* (1767). Maria Teresa's views. Joseph II's reforms. Redemption of service in sogage.

CHAPTER III.

NATIONALITY. (pp. 196—246.)

Disastrous consequences of the Turkish occupation. The Magyar element in the Alföld. The seats of ancient civilization suffered most. Lady Montague's remarks on the depopulation of Hungary. Its speedy recovery. Kollonic's project of colonisation.

I. *The Rascians (Serbs) in the Alföld*, pp. 201—204. Their colonisation. Their relations to Russia and the Czar. Want of civilization. Their character.

II. *The German Settlers in the Alföld*, pp. 204—211. Districts from which they came. Their distribution in both town and country. Character of German peasants and artisans. The causes of Hungarian hatred of Germans.

III. *The Magyar Settlers in the Alföld*, pp. 211—246. Their distribution. The Harrucker family send the immigrants into the county of Békés. Croatian colonies. Changes in nationality since that time. The Slovak colonists a bar to German and Rascian expansion, an aid to Magyardom. Magyar colonies. Advance of civilization. Cessation of the Oriental plague. Danger of religious persecution. Influence of Prussia for toleration. The Catholic Church and the Serbs. The nobles are Magyars. Their influence on the settlers. Magyar language and dress largely adopted in Croatia and elsewhere. Examples to prove that the Slovak and Croatian counties were actually foremost in the struggle of the Magyar against the German language. The process of Magyarisation imperceptible and not forcible. Magyar names. Opinions of the writers George Besseneyi, Lawrence Orczi, Paul Ányos. Magyar Literature (pp. 235—243). Endeavour to polish the language. 1772 not the starting-point of a new era in Hungarian literature. Religious dissensions prove the principal obstacle to progress. The influence of the Hungarian noble guard at Vienna. Foreign influences and Hungarian patriotism illustrated from Orczi. The Magyar peasant (pp. 243—246), Emperor Joseph's opinion of. Chief qualities of the Magyar serf. The development consisted in the victory of the farmer over the herdsman, and the transformation of the Alföld from pasture into arable land. The struggle between nobles and peasants constituted no danger to Hungarian nationality.

CHAPTER IV.

THE CHURCH. (pp. 247—300.)

Connection between Church and State. Advance of Protestantism (Lutheran and Calvinist). The prelates and the Counter-Reformation. Catholicism and the Habsburg. The two faiths and national tradition. Causes of the victory of Catholicism illustrated. The epic of the *Zrínyiász* (1646). The Catholic magnates and Peter Pázmány. Francis Rákóczi II and the policy of religious toleration and political union against Germans. The *Regnum Marianum* and Leopold I's intolerance towards Protestantism. Articles of 1681—87. Restriction of the exercise of Protestant worship to specified places (*articularis*). Comparison with Spain and France.

I. pp. 254—261. Legal situation since 1715. The *Carolina Resolutio*. Foreign powers and Protestantism. Maria Teresa more intolerant than her father Charles III (VI). Exclusion of Protestants from office. The oath. Bishop Biró of Veszprém's attack. Cases of persecution. Bajtay's advice. Frederick II and the Pope Benedict XIV condemn Bishop Biró's book, the *Enchiridion de fide*, published 1750.

II. pp. 261—269. Grievances of the Protestants. *Reversalis*. Mixed marriages. Apostasy. Case of Agnes Bánffy. Intolerance in Transylvania. Protestants and their guilds forced to take part in Catholic ceremonial processions, etc. Their churches and schools taken away. Burial and Christening fees demanded of Protestants by the Catholic Priests. Superintendents forced to undergo the visitation of Catholic Bishops. Renegades. *Juramentum decretale*. Exclusion of Protestants from office in the chief cities and also to some extent in the counties. Union of Catholics and Protestants against arbitrary government.

III. pp. 269—277. Strength of the Catholic party. Policy of converting and teaching. Influence of the Franciscan friars. Restoration of the Church in the districts formerly occupied by the Turks. Kalocsa. Veszprém. The Jesuits. Their merits in regard to historiography. Their interpretation of national history. Marian congregations. Wonder-working images. Prayers and preaching. Religious life.

IV. pp. 277—288. Power of the Catholic Hierarchy. Incomes of the prelates. Political influence. The Primate (Archbishop of Esztergom). Privileges of the prelates. Count Batthyány. Count Ch. Eszterházy. Visitation. *Főispán*-prelates. Prelates in the King's Bench. The official language. The canons. The lower clergy—half gentlemen, half peasants. *Congrua*. The Piarists. Difference between them and the Jesuits. Methods of education. Catholic and Greek Church union. Results more pretentious than important.

V. pp. 288—297. Organisation and strength of Protestantism. Lutherans and Calvinists. Political characteristics of Calvinism. Religion of the gentry and of the Magyar towns. Struggle for the constitution. In what the wealth of Hungarian history consists. Lutheranism is the religion of the German and Slav *bourgeoisie*. Education of Calvinists. Foreign universities. School organisation. Colleges of Debreczen and Sáros-Patak. Morals. Learning. Accounts given by Kazinczy and Bessenyei. Lutheran schools. Relations between the teachers and the nobles. Low position of the Protestant pastors and teachers. Struggle for the schools. Prayers. The Court and the Protestants.

VI. pp. 297—300. Beginnings of a better understanding between Catholics and Protestants. Literature, social intercourse. Humanity. Influence of Freemasonry. Indifferentism. Government against it. Religious schism no longer a national danger nor a source of fundamental division in 1780.

CHAPTER V.

THE ROYAL POWER AND THE GOVERNMENT OF THE STATE.
 (pp. 301—357.)

Principles of the Hungarian monarchy. Relation of the King to the Estates in Parliament.

I. pp. 303—307. The Holy Crown as representative of the State. The King is the State personified. The decadence of kingdom. The Estates become unable to fulfil their mission. They invest the King with a dictatorship before Mohács (1526). Merits of the Habsburg Kings. The two alternatives: absolutism and strength; opposition and discord. The modern conception of the State appears as a foreign innovation to Hungarians. The compromise arrived at between the modern sovereign and the medieval society.

II. pp. 308—320. Position of the King. Hereditary in both lines. The apostolic title. Theory of his power. Personal prerogative: *jus patronatus*; education; power over the Protestant churches. *Jus nobilitandi*. Granting of privileges. He is judge in cases of *lèse-majesté*. His Jurisdictional power. Devolution of noble estates. Power of interpreting the laws. Law and custom. Appointment of magistrates. Granting of pardons. Rights over the coinage. Limits of

King's power. War and peace. His power in Parliament. Hungarian Kingship does not correspond with Montesquieu's description of it or with his theories. The King as head of foreign organisations. The Army. The Serbs. The Jews. The King's control over the revenues of the Mines. Only part of his income is voted by Parliament. The *quota* of the Court. Postal Service. Great difference between the legal right and the actual power of Parliament in Hungary.

III. pp. 321—327. The King of Hungary as sovereign of Bohemia and Austria. Confederation of the Estates (1606). Conquest of Bohemia (1620–21). “Empire” of the Habsburgs. Catholicism; aristocracy. Results in Hungary. Protestantism vanquished; *jus resistendi* abolished (1687). Obstacles. National feeling. Hungary is content.

IV. pp. 327—347. Instruments of the King. *Dicasteria*. Chancellery. Its activity. Dependence upon the King. Its members. *Consilium locumtenentiale*. Its legal independence and actual nullity. Its instructions. Weak side of its system. The *Curia* and the King's Bench. Abuses. National spirit. The Royal Chamber. Foreign spirit; unpopularity. The counties and the *főispán*.

V. pp. 347—357. The *diploma inaugurale*. History. Power of law. Coronation. Its singular importance. Maria Teresa's *diploma*. Influence of Parliament. The Palatine. The taxes. The nobles have exemption from taxation. Insurrection. Decadence of Parliament. National organs really to be found in the assemblies of the counties and in the Courts of Law.
