The second volume of *The Cambridge History of Communism* explores the rise of communist states and movements after World War II. Leading experts analyze archival sources from formerly communist states to reexamine the limits to Moscow's control of its satellites; the de-Stalinization of 1956; communist reform movements; the rise and fall of the Sino-Soviet alliance; the growth of communism in Asia, Africa and Latin America; and the effects of the Sino-Soviet split on world communism. Chapters explore the cultures of communism in the United States, Western Europe and China, and the conflicts engendered by nationalism and the continued need for support from Moscow. With the danger of a new cold war developing between former and current communist states and the West, this account of the roots, development and dissolution of the socialist bloc is essential reading.

NORMAN NAIMARK is Robert and Florence McDonnell Professor of East European Studies and Senior Fellow, Hoover Institution and Freeman-Spogli Institute, Stanford University. He has conducted extensive research abroad in Russia, Poland and Germany on a variety of books, including *The Origins of the "Proletariat"* (1979), *Terrorists and Social Democrats* (2013), *The Russians in Germany* (1995), *Fires of Hatred* (2001), *Stalin's Genocides* (2010) and, most recently, *Genocide: A World History* (2017).

SILVIO PONS is Professor of Contemporary History at the University of Rome "Tor Vergata." He is the president of the Gramsci Foundation in Rome and a member of the Editorial Board of the *Journal of Cold War Studies*. His main publications include *Stalin and the Inevitable War* (2002), *Reinterpreting the End of the Cold War* (2005), *A Dictionary of Twentieth-Century Communism* (2010) and *The Global Revolution: A History of International Communism* (2014).

SOPHIE QUINN-JUDGE is the author of *Ho Chi Minh: The Missing Years* (2003) and *The Third Force in Vietnam: The Elusive Search for Peace* (2017). She was Associate Professor of History and Associate Director of the Center for Vietnamese Philosophy, Culture and Society at Temple University before retiring in 2015.

The Cambridge History of Communism is an unprecedented global history of communism across the twentieth century. With contributions from a team of leading historians, economists, political scientists and sociologists, the three volumes examine communism in the context of wider political, social, cultural and economic processes, while at the same time revealing how it contributed to shaping them. Volume I deals with the roots, impact and development of communism, analyzing the tumultuous events from the Russian Revolution of 1917 to World War II, and historical personalities such as Lenin, Stalin and Trotsky. Volumes II and III then review the global impact of communism, focusing on the Cold War, the Chinese Revolution, the Vietnam War and the eventual collapse of the Soviet Union. Together the volumes explain why a movement that sought to bring revolution on a world scale, overthrowing capitalism and parliamentary democracy, acquired such force and influence globally.

CHARLES ARMSTRONG is The Korea Foundation Professor of Korean Studies in the Social Sciences in the Department of History at Columbia University. He is the former director of Columbia's Center for Korean Research and former acting director of the Weatherhead East Asian Institute. He is the author, editor or coeditor of five books, including most recently *Tyranny of the Weak: North Korea and the World, 1950–1992* (2013; winner of the John Fairbank Prize of the American Historical Association) and *The Koreas* (2nd edn., 2014).

JÖRG BABEROWSKI is Professor of East European History at Humboldt-University in Berlin, Germany. He is the author of many books and articles on Russian and Soviet history, among others *Scorched Earth: Stalin's Rule of Violence* (2016).

IVO BANAC is Bradford Durfee Emeritus Professor of History at Yale University and Professor of History at the University of Zagreb. His award-winning books are *The National Question in Yugoslavia: Origins, History, Politics* (1984; winner of the Wayne S. He is also a corresponding member of the Croatian Academy of Sciences and Arts (HAZU).

THOMAS P. BERNSTEIN is Professor Emeritus of Political Science, Columbia University. Among his publications are *Taxation Without Representation in Contemporary China*, coauthored with Xiaobo Lu (2003) and *Up to the Mountains and Down to the Villages: The Transfer of Youth from Urban to Rural China* (1977), as well as articles on Chinese politics, Soviet and Chinese collectivization and the Soviet and Chinese famines of 1932–33 and 1959–61. Her books include *We Are No Longer in France: Communists in Colonial Algeria* (2014), *Between Empire and Revolution: A Life of Sidney Bunting* (2007), *Discordant Comrades: Identities and Loyalties on the South African Left* (2000) and *South Africa's Radical Tradition: A Documentary History* (1996–97).

JOHAN FRANZÉN is a historian of the modern Middle East, and Senior Lecturer (Associate Professor) at the University of East Anglia, UK. He is the author of *Red Star over Iraq: Iraqi Communism Before Saddam* (2011) and has written extensively on the history of communism, nationalism and anti-imperialist thought in the Arab world.

PIERO GLEJJESES is Professor of American Foreign Policy at the Paul H. Nitze School of Advanced International Studies, Johns Hopkins University. His most recent book is *Visions of Freedom: Havana, Washington, Pretoria and the Struggle for Southern Africa, 1976–1991* (2013), which was awarded the Friedrich Katz Prize from the American Historical Association.

GIOVANNI GOZZINI is full professor of Contemporary History at the University of Siena, Italy (Department of Social, Political and Knowledge Sciences). of books, including *The Origins of the “Proletariat”* (1979), *Terrorists and Social Democrats* (2013), *The Russians in Germany* (1995), *Fires of Hatred* (2001), *Stalin’s Genocides* (2010) and, most recently, *Genocide: A World History* (2017).

SILVIO PONS is Professor of Contemporary History at the University of Rome “Tor Vergata.” He is the president of the Gramsci Foundation in Rome and a member of the Editorial Board of the *Journal of Cold War Studies*. His main publications include *Stalin and the Inevitable War* (2002), *Reinterpreting the End of the Cold War* (2005), *A Dictionary of Twentieth-Century Communism* (2010) and *The Global Revolution: A History of International Communism* (2014).

SOPHIE QUINN-JUDGE is the author of *Ho Chi Minh: The Missing Years* (2003) and *The Third Force in Vietnam: The Elusive Search for Peace* (2017). She was Associate Professor of History and Associate Director of the Center for Vietnamese Philosophy, Culture and Society at Temple University before retiring in 2015.

SERGEY RADCHENKO is Professor of International Relations at Cardiff University. He is the author of *Two Suns in the Heavens: The Sino-Soviet Struggle for Supremacy, 1962–1967* (2009) and *Unwanted Visionaries: The Soviet Failure in Asia at the End of the Cold War* (2014).

ALFRED J. RIEBER has been teaching and writing about Russian and Soviet history for more than fifty years. For the past twenty years he has taught at the Central European University (CEU) in Budapest, Hungary, where he was also chair of the History Department for four years, and where he now serves as University Professor Emeritus. His most recent scholarly books are *Struggle for the Eurasian Borderlands: From the Rise of Early Empires to the End of the First World War* (2014) and *Stalin and the Struggle for Supremacy in Eurasia* (2015). He is also the author of three historical detective novels, *To Kill a Tsar*, *The Kiev Killings* and *Siberian Secrets*.

FEDERICO ROMERO is Professor of History of Post-War European Cooperation and Integration at the Department of History and Civilization, European University Institute, Florence, where he directs the European Research Council project “Looking West: The European Socialist Regimes Facing Pan-European Cooperation and the European Community.” A specialist on twentieth-century international and transnational history, he has worked on various aspects of the Cold War and trans-Atlantic relations, particularly the Marshall Plan and postwar European reconstruction. In 2009 he published *Storia della guerra fredda*.

JOHN ROOSA is the author of *Pretext for Mass Murder: The September 30th Movement and Suharto’s Coup d’État in Indonesia* (2006) and numerous articles on the events of 1965–66 in Indonesia. As Associate Professor in the History Department at the University of British Columbia, Vancouver, he specializes in Southeast Asian history. He has also studied South Asia and has written an article on the largest communist revolt in twentieth-century India: “Passive Revolution Meets Peasant Revolution: Indian Nationalism and the Telangana Revolt,” *Journal of Peasant Studies* (2001).
