CHAP. I. The Present Undertaking 1

The core of drama is not character, but situation, an effect of compression and contrast; the most striking generally secured at great cost to probability. The present writer's purpose.

CHAP. II. *Othello* 6

§ 1. The hero a prey to passions foreign (in a sense) to his nature. The convention of the calumniator credited, in this and other plays of Shakespeare. § 2. The psychological improbability in the play, by some critics now recognized. § 3. There is jealousy, without the predisposition; though Coleridge denied the former, and Schlegel posited the latter. § 4. The psychological improbability, price of a great contrast, made possible by an initial postulate—that Othello's mind is open and Iago's impenetrable—and made acceptable by the powerful and skilful dramatic and poetic treatment. § 5. Made acceptable above all by the creation of an illusion, through the emotional energy set free not only by the initial postulate, but by complementary, supporting fictions, or extensions of this:—that Othello's mind should *not* be thus open, and that Iago's should be closed, to others; that Iago should seem honest and sagacious to all. The case of Emilia's conduct, hitherto interpreted as stupidity or disloyalty. § 6. On the two interdependent fictive contrasts, of Iago's honesty and of Othello's jealousy, the structure of the play depends; the reconciliation of opposite or discordant qualities being in part achieved, and the emotional effect heightened, by a dramatic and poetic method that approaches the musical. § 7. A musical method in the development, but the principles of relative representation

followed are more apparent when we turn to painting. § 8. Such essential unity of purpose not really inconsistent with Shakespeare's frequent laxity of structure and carelessness in detail; nor fine character-drawing with a want of psychology. § 9. By this interpretation the spectator or reader, freed of psychological questionings and realistic misgivings, is more able to respond imaginatively to the force and charm of the characters; and to the intense situation, best appreciated, despite their psychological prepossession, by Coleridge and De Quincey.

CHAP. III. Parallels to this artificial but effective contrast, Ancient, Medieval, and Modern; in the Drama, the Epic, and the Novel.

§ 1. The duty imposed at the beginning and deferred till the end (with the intervening, apparently irrelevant, activity) part and parcel of the old play, and therefore of this. § 2. The leading character necessarily, and here actually, a hero; and the delay, customary in revenge tragedies, not to his discredit. irony (until late in the eighteenth century) in the opinion of both the public and the critics; and this opinion justified by the text. § 4. The tragedy cannot be both what it was in its own day manifestly intended and understood to be, and also what it has been taken to be of late. § 5. By this interpretation the feigned madness, and the hero's whole character, particularly his reticence, are more intelligible and appreciable. § 6. Shakespeare himself concerned less with minor consistency in character or story than with the dramatic interest and illusion, the attraction of the hero and an emotional effect. A musical method. § 7. The Grave-diggers' scene as an illustration. § 8. The present interpretation in harmony with the later opinions of Mr Clutton-Brock.

CHAP. IX. Comedy and Tragedy considered together 155

§ 1. What is lacking in modern comedy and tragedy both is for the most part what is misapprehended in Shakespeare, the "bold strokes" and the "precipitation of spirit", richer in effect than is realism. § 2. Therefore the best comic and tragic writers, like Pirandello and O'Neill, are now falling back upon what are modern and contemporary equivalents of the outworn artifices, such as slander and disguise. Such artifices serve an unchanging need in drama—that of accumulation and compression, to make us think and feel.—The still higher need in tragedy, that of a reconciliation to life, in the moderns and in Shakespeare.
