He has edited *The Cambridge Companion to Utopian Literature* (Cambridge University Press, 2010), *The Cambridge History of Nineteenth-Century Political Thought* (with Gareth Stedman Jones, Cambridge University Press, 2011) and some fifty volumes of primary sources and criticism.

MIKE GANE is Professor Emeritus in the School of Social Sciences, Loughborough University, UK. He has degrees from Leicester University (BA Sociology) and the LSE (PhD Sociology). His main focus of research has concerned the origins and development of social theory with monograph studies of Comte, Durkheim and Mauss, Foucault and Baudrillard. of the History of Political Thought. He works on the history of political thought (British, French and American, nineteenth and twentieth centuries), with particular emphasis on political thought on nationalism, patriotism and cosmopolitanism, intellectual history of ideas of ‘the West’ and ideas of ‘Europe’ and political thought on international relations and imperialism. His books include *Liberty Abroad: J. S. Mill on International Relations* (2013), *Mill on Nationality* (2002), *Victorian Political Thought on France and the French* (2002) and *Contemporary France: An Introduction to French Politics and Society* (with David Howarth, 2003).

NORBERT WASZEK is Professor of German (History of Ideas) at the University of Paris VIII. He was educated in Germany (MA Bochum 1978), in Scotland (MLitt. Stirling 1980) and at Cambridge (PhD Christ’s College 1984), then submitted his professorial thesis (Habilitation) at the Sorbonne (Paris I, 1998). His books include *Man’s Social Nature: A Topic of the Scottish Enlightenment in Its Historical Setting* (1986) and *The Scottish Enlightenment and Hegel’s Account of Civil Society* (1988).
