ing to take, any sum or sums of money, for any benefice or living, to forfeit double the sum or sums of money; and every one paying such sum or sums, to be incapable of holding the place for that time. At every election, presentation, &c. the statutes relating to the same to be publicly read; in default thereof, a forfeit of forty pounds to be paid, which may be sued for and recovered in any of her Majesty's courts. To prevent simony and corruption, if any person or persons bestow any benefice or living whatsoever, for any corrupt cause or consideration, the said benefice or living to be void. Any person or persons giving or taking such sums of money, to forfeit the double value of one year's profit; and any person using these practices to secure any benefice or living, to be adjudged disabled in law to have and enjoy the same. If the incumbent of any benefice corruptly resigns or exchanges the same, for any sum of money or benefit, the giver and taker of such sum or benefit to lose double the value of such sum; of which one moiety, as well as the double value of one year's profit, to go to the Queen, and one moiety to any one suing for the same in any of the courts of record. The act not retrospective.
