Middle-class asylums—One much wanted in the vicinity of London—Dr. Conolly exerted himself, supported by Lord Shaftesbury and others, to establish one, but failed to interest the public—A second attempt some years after had no better success—Later he assisted to establish the Coton Hill Asylum, near Stafford—Barnwood Asylum, near Gloucester, established on the same principle—Although intended chiefly for middle classes these asylums receive patients in affluent circumstances—No one derives any profit from the income—Surplus goes to lighten the payments of patients whose means are straitened—No paupers are received—These asylums are an unspeakable boon to clergymen, literary men, governesses, &c.—A class of asylums in Scotland named Chartered Asylums afford admission to both paying and pauper patients Page 102-109

Earlwood, National institution for the protection of the idiotic, and training of imbecile children—For the idea of this asylum the country indebted to *Mrs. Plumbé*, of London, by whose exertions it was established, aided by Dr. Conolly and Dr. Andrew Reed; assisted also by Mr. Charles Gilpin, M.P., Mr. Alderman Wise, and Sir George Carrol—Sir John Forbes became a member of the Board, giving Dr. Conolly the advantage of his constant moral support in the progress of the asylum—The lamented Prince Consort laid foundation stone of asylum Jan. 6th, 1853—Opened by His Royal Highness July 5th, 1855—Other asylums for idiots have since been established—By the Annual Report of Earlwood, 1867, there were 450 inmates, two-thirds males, one-third females, in the asylum—Extensive workshops and various industrial pursuits—150 acres of kitchen and pleasure grounds—A variety of amusements—Medal obtained by a pupil at Paris Exhibition—Interesting account of Dr. Conolly's visits to asylum—Dr. Down's resignation as Medical Superintendent—His retirement a great loss to asylum and to science—Meeting at Cambridge in favour of asylum—Speeches of Rev. FOREIGN ASYLUMS: *France*—Dr. Conolly's disappointment that in country of Pinel and Esquirol, non-restraint was not at once accepted—Alienist physicians of Paris have same humane feelings as the English to the insane—Ultimately their treatment will be identical—Great improvement in Paris asylums—Three new asylums lately erected, each containing 600 patients, surrounded by ample grounds for agriculture, gardening, recreation, workshops, &c.—Improvement in departmental asylums in M.
