Reasons why the Apocryphal Books were rejected from the Canon of Scripture:
I. THE APOCRYPHAL BOOKS POSSESS NO INTERNAL AUTHORITY TO PROCURE THEIR
ADMISSION INTO THE SACRED CANON.
1. Not one of them is extant in pure ancient Biblical Hebrew - 470
2. They were all written subsequently to the cessation of the Prophetic Spirit 470
3. Not one of the Writers or Authors of them, in direct terms, advances any claim
to Inspiration 470
4. The Apocryphal Books contain many Things which are either fabulous or con-
tradictory to the Canonical Scriptures in Facts, Doctrines, and Moral Practice,
and also contradictory to authentic profane History 471
[i.] Fabulous Statements 471
[ii.] Statements which are contradictory to the History related in the Canonical
Books, and to other statements contained in the Apocryphal Books 471, 472
[iii.] Contradictory Doctrines 472
[iv.] Immoral Practices commended in the Apocryphal Books, which practices are
prohibited in the Scriptures 473
[v.] Passages in the Apocryphal Books which are so inconsistent with the relations
of all other profane Historians, that they cannot be admitted without much
greater Evidence than belongs to these Books 473
II. THE APOCRYPHAL BOOKS POSSESS NO EXTERNAL EVIDENCE TO PROCURE THEIR
ADMISSION INTO THE SACRED CANON.
1. They were never received into the Sacred Canon by the ancient Jewish Church:
and therefore they were not sanctioned either by Jesus or by his divinely
inspired Apostles 474—479 2. No Jewish Writers, subsequent to the time of Jesus Christ, have cited the Apo-
cryphal Books as forming part of their Canon of Scripture. On the contrary,
many eminent Jewish Writers have altogether rejected them - 479
3. The Apocryphal Books were not admitted into the Canon of the divinely
inspired Scriptures in any Catalogue of the Sacred Books recognised by any
Council of the ancient Christian Church, nor in any Catalogues published by the
Fathers or Ecclesiastical Writers of the first four Centuries - 480—499
4. Testimonies of the principal later Divines of the Eastern or Greek Church, and
of the Latin or Western Church, from the fifth to the fifteenth Century, that
the Apocryphal Books form no part of the Canon of divinely inspired
Scripture 499—502
5. Confessions of learned Romanists in the sixteenth Century, who lived before,
during, and after the so-called Council of Trent, that the Apocryphal Books
are no part of the Canon of the divinely inspired Scriptures - 503-505
6. The Apocryphal Books are rejected by the Oriental or Greek Church from the
Canon of Scripture 505, 506
The uninspired Apocryphal Books placed in the same rank with the inspired
Writings by the modern so-called Council of Trent 507 III. Actual Value of the Apocryphal Books 509, 510
