The Cambridge Companion to Jewish Theology offers an overview of Jewish theology, an aspect of Judaism that is equal in importance to law and ethics. Covering the period from antiquity to the present, the volume focuses on what Jews believe about God and also about the relation of God to humans and the world. Parts I and II cover exciting new research in Jewish biblical and rabbinic theology, medieval philosophy, Kabbalah (mysticism), and liturgy. Parts III and IV turn to modern theology with an exploration of works by leading figures, such as Rabbi Abraham I. Kook, Franz Rosenzweig, and Emmanuel Levinas, as well as the relation of theology to issues such as feminism and the Holocaust, and the relation of Judaism to other world religions. In Part V, the book explores how the insights of analytic philosophy have been integrated with Jewish theology.

STEVEN KEPNES is Professor of Religion and Jewish Studies at Colgate University. He is the author of *The Future of Jewish Theology and Jewish Liturgical Reasoning* (2007).

Notes on Contributors

Adam Afterman is Associate Professor in Jewish Philosophy and Mysticism at Tel Aviv University and Chair of the Department of Jewish Philosophy and Talmud. He is a Senior Research Fellow at the Shalom Hartman Institute Kogod Research Center for Contemporary Jewish Thought in Jerusalem and the John Paul II Center for Interreligious Dialogue. His most recent book "And They Be One Flesh": On the Language of Mystical Union in Judaism (2016) explored the linguistic developments within Jewish mysticism concerning the mystical union of the human and divine.

Alan Brill is the Cooperman/Ross Endowed Chair for Jewish-Christian Studies at Seton Hall University, where he teaches Jewish studies in the graduate program. Brill is the author of *Thinking God: The Mysticism of Rabbi Zadok of Lublin* (2002), *Judaism and Other Religions: Models of Understanding* (2010), and *Judaism and World Religions* (2012). He was a Fulbright Senior Scholar awardee to research and teach at Banares Hindu University in Varanasi, India, which is the subject of a recent book, *Rabbi on The Ganges: A Jewish Hindu Encounter* (2019).

Richard A. Cohen is Professor of Jewish Thought, and of Philosophy, at the University at Buffalo (SUNY). He is author of Out of Control: Confrontations between Spinoza and Levinas (2016), Levinasian Meditations: Ethics, Philosophy, and Religion (2010), Ethics, Exegesis and Philosophy: Interpretation after Levinas (2001), Elevations: The Height of the Good in Rosenzweig and Levinas (1994); editor and author of many other writings in contemporary continental philosophy and Jewish thought; and Director of the annual Levinas Philosophy Summer Seminar.

Cass Fisher is an Associate Professor in Religious Studies at the University of South Florida. He is a philosopher of religion focusing on rabbinic theology and modern Jewish thought. His first book, Contemplative Nation: A Philosophical Account of Jewish Theological Language (2012), presents a new model for understanding Jewish theology that emphasizes the multiple forms and functions of Jewish theological language and grounds theological reflection within religious practice. He is currently working on a second book titled, As If It Could Be Said: Realism, Reference, and the Limits of Jewish Theological Language,

sections of which have recently appeared in *Harvard Theological Review*, *AJS Review*, and *Religions*.

Samuel Fleischacker is LAS Distinguished Professor of Philosophy at the University of Illinois in Chicago and Director of Jewish Studies there. He is the author of nine books, including two on revealed religion: *The Good and the Good Book* (2015) and *Divine Teaching and the Way of the World* (2011). He has also edited a collection entitled *Heidegger's Jewish Followers* (2008), and written on revelation for Torah.com.

Daniel Frank is Professor of Philosophy and Jewish Studies at Purdue University. Among recent books are *Spinoza on Politics* (with Jason Waller, 2016), *Jewish Philosophy Past and Present: Contemporary Responses to Classical Sources* (coedited with Aaron Segal, 2017), and *Cambridge Critical Guide to Maimonides' Guide of the Perplexed* (co-edited with Aaron Segal, forthcoming).

Jerome Yehuda Gellman is Professor Emeritus of the Department of Philosophy at Ben-Gurion University. He has published widely on analytic philosophy of religion, Jewish theology, and philosophical topics in Hasidism. His last three books present contemporary Jewish theologies on, respectively: the Jews as the Chosen People, Torah and the critique of history, and the perfect goodness and the God of the Hebrew Bible and rabbinic literature.

Alon Goshen-Gottstein is acknowledged as one of the world's leading figures in interreligious dialogue. He is founder and director of the Elijah Interfaith Institute since 1997. His work bridges the theological and academic dimension with a variety of practical initiatives, especially involving world religious leadership. His academic work is divided between contributions to early rabbinic thought, Jewish spirituality, interfaith theory, and Jewish Theology of Religions. He has held academic posts at Hebrew University of Jerusalem and Tel Aviv University, and has served as Director of the Center for the Study of Rabbinic Thought, Beit Morasha College, Jerusalem.

Moshe Halbertal is the John and Golda Cohen Professor of Jewish Thought and Philosophy at the Hebrew University and the Gruss Professor at NYU Law School, and a member of the Israel's National Academy for Sciences and the Humanities. His latest book *The Birth of Doubt: Confronting Uncertainty in Early Rabbinic Literature* (2020) was published in the Brown Judaic Series.

Ronit Irshai is an Associate Professor in the gender studies program at Bar Ilan University and a research fellow at the Shalom Hartman Institute in Jerusalem. Her first book *Fertility and Jewish Law – Feminist Perspectives on Orthodox Responsa Literature* was published in 2012. She is now working on two new books: The first examines modern halakhic texts, in order to show how male and female identities are constructed by contemporary halakhic rulings. The second book (together with Dr. Tanya Zion-Waldox and Banna Shoughry) compares Jewish Orthodox feminism and Islamic feminism in Israel.

Steven Kepnes is Professor of World Religions and Jewish Studies and Director of Chapel House at Colgate University, Hamilton, NY. He is the author of seven

books including The Future of Jewish Theology (2013), Jewish Liturgical Reasoning (2007), and The Text As Thou: Buber's Hermeneutics (1993).

Reuven Kimelman is Professor of Classical Judaica at Brandeis University. His Ph.D. is from Yale University. He is the author of *The Mystical Meaning of 'Lekhah Dodi' and Kabbalat Shabbat* (2003), and forthcoming *The Rhetoric of the Liturgy: A Historical and Literary Commentary to the Jewish Prayer Book*. His audio course books are *The Hidden Poetry of the Jewish Prayer Book* (2006) and *The Moral Meaning of the Bible* (2006).

Michael L. Morgan is emeritus Chancellor's Professor of Philosophy and Jewish Studies at Indiana University, Bloomington, and emeritus Grafstein Chair in Philosophy and Jewish Studies at the University of Toronto. He has also taught at Yale, Princeton, Northwestern, and Stanford. He is the author or editor of over twenty books and the author of dozens of papers on the history of philosophy and Jewish philosophy. His most recent books are *Levinas's Ethical Politics* (2016) and *The Oxford Handbook of Levinas* (2019).

David Novak is the J. Richard and Dorothy Shiff Professor of Jewish Studies and Philosophy in the University of Toronto, and President of the Union for Traditional Judaism. He is a Fellow of the Royal Society of Canada and of the American Academy for Jewish Research. Among his many books are: *Natural Law in Judaism* (2008), *Covenantal Rights* (2009), and *Athens and Jerusalem: God, Humans, and Nature* (2019) (based on his 2017 Gifford Lectures at the University of Aberdeen).

Tamar Ross is Professor Emerita of the Department of Jewish Philosophy at Bar Ilan University. She has taught in many academic and religious settings in Israel and abroad and publishes widely on various topics relating to Jewish thought. Her particular areas of interest include: contemporary challenges to traditionalist Jewish theology (including feminism, historicism, biblical criticism, and postmodernity); concepts of God, divine revelation, religious epistemology, and hermeneutics; philosophy of halakhah; the Musar movement (a modern pietist movement devoted to the development of spiritual discipline and moral conduct); and the thought of the twentieth-century mystic, Rabbi A. I. Kook.

Daniel Rynhold is Professor of Jewish Philosophy and Dean at the Bernard Revel Graduate School of Jewish Studies, Yeshiva University. He has published on numerous topics in Jewish philosophy, and is the author of *Two Models of Jewish Philosophy: Justifying One's Practices* (2005), *An Introduction to Medieval Jewish Philosophy* (2009), and (co-authored with Michael J. Harris) *Nietzsche, Soloveitchik, and Contemporary Jewish Philosophy* (2018).

Kenneth Seeskin is Professor of Philosophy and the Philip M. and Ethel Klutznick Professor of Jewish Civilization at Northwestern University. He has taught at Northwestern since 1972 and has served as Chair of the Philosophy Department as well as the Religious Studies Department. He is the author of Searching for a Distant God (2000), Maimonides on the Origin of the World (2007), and Jewish Messianic Thoughts in an Age of Despair (2012). His most

recent publications include *Thinking about the Torah: A Philosopher Reads the Bible* (2016) and *Thinking about the Prophets: A Philosopher Reads the Bible* (2020).

Jules Simon is a Professor in the Department of Philosophy at the University of Texas at El Paso in El Paso, Texas—on the border of Mexico and the USA. As a philosopher, he writes, teaches, and lectures in the areas of phenomenology, ethical theory, aesthetics, and Jewish philosophy. He has published extensively in the area of Jewish philosophy, including an original monograph, Art and Responsibility: A Phenomenology of the Diverging Paths of Rosenzweig and Heidegger (2011), two edited books focusing on ethics and genocide—History, Religion, and Meaning: American Reflections on the Holocaust and Israel (2000) and The Double Binds of Ethics after the Holocaust: Salvaging the Fragments (2009)—and a Festschrift for John Haddox, Thought and Social Engagement in the Mexican-American Philosophy of John H. Marvin A. Sweeney is Professor of Hebrew Bible at the Claremont School of Theology. He is the author of sixteen volumes in the fields of Bible and Jewish Studies, such as *Tanak: A Theological and Critical Introduction to the Jewish Bible* (2012) and *Reading the Bible After the Shoah: Engaging Holocaust Theology* (2008).
