This book addresses some of the most difficult and important debates over injury and law now taking place in societies around the world. The essays tackle the inescapable experience of injury and its implications for social inequality in different cultural settings. Topics include the tension between physical and reputational injuries, the construction of human injuries versus injuries to nonhuman life, virtual injuries, the normalization and infliction of injuries on vulnerable victims, the question of reparations for slavery, and the paradoxical degradation of victims through legal actions meant to compensate them for their disabilities. Authors include social theorists, social scientists, and legal scholars, and the subject matter extends to the Middle East and Asia, as well as North America.

Samantha Barbas is Professor of Law at the University at Buffalo School of Law. She holds a PhD in US History from the University of California, Berkeley, and a JD from Stanford Law School. Her research focuses on media law and history in the United States. She is the author of four books on American cultural history, film, journalism and the law, including *Laws of Image: Privacy and Publicity in America* (2015), and *Newsworthy: The Supreme Court Battle over Privacy and Press Freedom* (2017).

Pratiksha Baxi is Associate Professor at the Centre for the Study of Law and Governance, Jawaharlal Nehru University, New Delhi. Her research interests lie at the intersection of legal anthropology, feminist theory, and violence studies. She is the author of *Public Secrets of Law: Rape Trials in India* (2014), which was shortlisted for the Crossword Book Award (Nonfiction category). Baxi is the coeditor of the *Contributions to Indian Sociology*. Baxi anchors the *Law and Social Sciences Research Network* (LASSnet), which brings together scholars engaged in interdisciplinary research on law in the region.

Anne Bloom is Executive Director of the Civil Justice Research Institute, a think tank affiliated with the UC Berkeley and UC Irvine Schools of Law. Her background is in both academia and public interest law. Previously, she was Associate Dean for Research and Professor of Law at McGeorge Law School, Director of Public Programs at Equal Justice Works, and a staff attorney with the national public interest impact litigation firm, Public Justice. She holds both a JD and a PhD in political science and has authored many articles on injury-related topics.

Li Chen is Associate Professor of History and Chair of the Department of Historical and Cultural Studies at the University of Toronto. He

is the founding president of the International Society for Chinese Law and History and a member of the Editorial Board of the *Law and History Review*. He holds a JD from the University of Illinois (Champaign) and PhD in history from Columbia University. Besides a number of articles on law, empire, and international politics, his recent publications include a monograph entitled *Chinese Law in Imperial Eyes: Sovereignty, Justice, and Transcultural Politics* (2016), which won honorable mention for the 2017 Peter Gonville Stein Book Award of the American Society for Legal History, and a coedited volume, *Chinese Law: Knowledge, Practice and Transformation, 1530s–1950s* (2015). His research focuses on the intersections of law, culture and politics in Chinese and global history since the sixteenth century.

David M. Engel is SUNY Distinguished Service Professor of Law at the State University of New York at Buffalo. He is former President of the Law & Society Association and the recipient of its 2017 Kalven Award for Outstanding Scholarship in Law and Society. Engel's research examines law, culture, and society in America and Thailand. His book, *The Myth of the Litigious Society: Why We Don't Sue* (2016) explains why American injury victims generally avoid claiming. His scholarship on Thailand, where he has lived, worked, and taught for many years, includes the book *Tort, Custom, and Karma: Globalization and Legal Consciousness in Thailand* (2010), which examines the effects of global transformations on Thailand's legal culture. Engel is a visiting professor at the Chiang Mai University Law School, where he received an honorary doctorate in 2011. He currently serves as an Editor-in-Chief of the *Asian Journal of Law and Society* and is a member of the inaugural Board of Trustees of the Asian Law and Society Association.

Martha Albertson Fineman is Robert W. Woodruff Professor of Law at Emory University School of Law. An internationally recognized law and society scholar, Fineman is a leading authority on family law and feminist jurisprudence. Before coming to Emory, Fineman taught at the University of Wisconsin and Columbia University, and was on the Cornell Law School faculty, where she held the Dorothea Clarke Professorship, the first endowed chair in the

nation in feminist jurisprudence. Fineman is founder and director of the Feminism and Legal Theory Project, which was inaugurated in 1984 and also serves as director of Emory's Vulnerability and the Human Condition Initiative.

Mary Anne Franks is Professor of Law at the University of Miami and the Vice-President and Legislative & Tech Policy Director of the Cyber Civil Rights Initiative. Her publications include a forthcoming book on constitutional fundamentalism and dozens of articles in publications such as the *California Law Review*, *UCLA Law Review*, *The Atlantic*, and *TIME*. She is an internationally recognized expert on “revenge porn” and online harassment. She coproduced the documentary “Hot Girls Wanted” and is also a Krav Maga instructor. She holds a JD from Harvard Law School and received doctorate and master's degrees from Oxford University as a Rhodes Scholar.

Marc Galanter is Professor of Law Emeritus at the University of Wisconsin Law School. Previously he was the John and Rylla Bosshard Professor of Law and South Asian Studies at the University of Wisconsin–Madison and LSE Centennial Professor at the London School of Economics and Political Science. He has lectured at more than eighty universities in the United States and abroad. He has taught South Asian Law, Law and Social Science, Legal Profession, Religion and the Law, Contracts, Dispute Processing and Negotiations. He has authored numerous books and articles related to law, the legal profession and the provision of legal services in India.

Jonathan Goldberg-Hiller is Professor of Political Science at the University of Hawai'i at Mānoa where he teaches sociolegal theory. He is the author of *The Limits to Union: Same-sex Marriage and the Politics of Civil Rights* (2004), *Plastic Materialities: Politics, Legality, and Metamorphosis in the Work of Catherine Malabou* (2015; with Brenna Bhandar) and has published widely on issues of legal aesthetics, sexuality, and indigenous rights. He is coeditor of a book series, *Global and Insurgent Legalities* at Duke University Press, and former coeditor of *The Law & Society Review*. He is currently writing a book on the legal and political significance of night.

Mary Beth Heffernan is Professor of Sculpture, Photography and Interdisciplinary Art and Chair of the Art and Art History Department at Occidental College. Her artwork explores representation and physicality, with a particular focus on the intersection of injury, illness, and images. Heffernan's Personal Protective Equipment (PPE) Portrait Project garnered international recognition for humanizing healthcare workers in the Liberian Ebola epidemic.

She is the author of *Inheritance of Loss: China, Japan, and the Political Economy of Redemption after Empire* (2016), which won two book awards from the American Anthropological Association: the Anthony Leeds Book Prize from the Society for Urban, National, and Transnational Anthropology and the Francis L. K. Hsu Book Prize from the Society for East Asian Anthropology.

Michael McCann is Gordon Hirabayashi Professor for the Advancement of Citizenship at the University of Washington. McCann is author of over sixty article-length publications, and author, coauthor, editor, or coeditor of eight books, including the multi-award-winning monographs *Rights at Work* (1994) and (with William Haltom) *Distorting the Law* (2004); each of these latter books won numerous professional prizes. McCann has been awarded many National Science Foundation (NSF) and other grants; was a Guggenheim Fellow and Fellow in Law and Public Affairs (Princeton); and won the Stanton Wheeler Mentorship Award (2017) from the Law

and Society Association, of which he was the elected President (2011–13).

Sagit Mor is Senior Lecturer at the University of Haifa Faculty of Law, Israel. She holds an LLM and a JSD from NYU School of Law and was an Ed Roberts postdoctoral fellow in disability studies at UC Berkeley. She won the Association for the Study of Law Culture and the Humanities 2007 Dissertation Award. Mor is the cofounder of the Collaborative Research Network of Disability Legal Studies at the Law and Society Association. Her publications examine the sociolegal construction of disability in various fields including employment law, access to justice, bioethics, torts, and social welfare. She is coeditor of *Disability Studies: A Reader* (Hebrew). Her current research focuses on disability critique of torts.

Arzoo Osanloo is Associate Professor in the Department of Law, Societies, and Justice and Director of the Middle East Center at the University of Washington. She holds a JD and a PhD in cultural anthropology. As a legal anthropologist, her research and teaching lie at the intersections of law and culture. Her book, *The Politics of Women's Rights in Iran* (2009), analyzes the politicization of “rights talk” after that country’s revolution. She is completing a manuscript that examines the Muslim mandate of mercy as it takes shape in Iran’s criminal justice system. Prior to her academic work, she was an immigration and asylum attorney.

Claire E. Rasmussen is Associate Professor and Director of Graduate Studies in the Department of Political Science and International Relations at the University of Delaware. Her work in political theory is interdisciplinary and her work has appeared in journals in Political Science, Geography, Feminist Theory, and Law and Society. She is the author of *The Autonomous Animal: Self-Governance and the Modern Subject* (2011). Yoshitaka Wada is Professor of Law at Waseda Law School, Tokyo. A graduate of Kyoto University, he has been engaged in studies of the theory of law and society and dispute resolution, including
