Notes on Contributors

Lyse Doucet OBE is the BBC's award-winning Chief International Correspondent, who spends much of her time covering stories in our news headlines, including devastating wars in Syria and Iraq as well as Afghanistan. She often focuses on the human costs of conflict. Her work also involves asking questions of world leaders. Her BBC journalism began with postings in Abidjan, Kabul, Islamabad, Tehran, Amman, and Jerusalem. She was awarded an OBE in the Queen's Honours list in 2014 for her services to broadcasting and the Columbia Journalism Award for lifetime achievement in 2016.

Andrew C. Fabian OBE is the former Director of the Institute of Astronomy at the University of Cambridge. He also leads the X-Ray research group within the Institute. The group's research focuses on active galaxies, clusters of galaxies, elliptical galaxies, galactic black holes, neutron stars, and the X-ray background. He is one of two UK members of the European Space Agency's Athena Science Study Team. Before becoming its Director, Professor Fabian was a Royal Society Research Professor in the Institute of Astronomy. Formerly, he was President of the Royal Astronomical Society and Vice-Master of Darwin College. He was made a Fellow of the Royal Society in 1996, a Foreign Associate of the US National Academy of Sciences in 2016, and he was awarded the American Astronomical Society's (AAS) Bruno Rossi Prize, the Dannie Heineman Prize for Astrophysics of the AAS and APS, and the Catherine Wolfe Bruce Gold Medal of the Astronomical Society of the Pacific. Asteroid 25157 Fabian was named for him in 2016. Inter alia, he is a co-editor of *Frontiers of X-Ray Astronomy* and of the Darwin Lecture Series volumes on *Origins, Evolution, Conflict, Darwin, and Life*.

Matthew Goodwin is Professor of Politics and International Relations at Rutherford College, University of Kent, and Senior Visiting Fellow at

Chatham House. In 2014 he received the Richard Rose Prize and the Communicator Prize for his dissemination of social science research to a wider audience. His books include *Revolt on the Right: Explaining Public Support for the Radical Right in Britain*, which was awarded the Paddy Power Political Book of the Year, and *Brexit: Why Britain Voted to Leave the European Union*.

Sarah Harper CBE is Professor of Gerontology at the University of Oxford and the Founding Director of the Oxford Institute of Population Ageing. Sarah served on the Council for Science and Technology, which advises the Prime Minister on the scientific evidence for strategic policies and frameworks. In 2017 she served as Director of the Royal Institution of Great Britain. Sarah is a Director and Trustee of the UK Research Integrity Office and a member of the Board of Health Data Research UK. Her latest book, *How Population Change Will Transform Our World*, is published by Oxford University Press. Sarah is a Fellow of the Royal Anthropology Institute and she was appointed a CBE in 2018 for services to Demography.

David Runciman is Professor of Politics and Head of the Department of Politics and International Studies (POLIS) at the University of Cambridge. His books include *The Confidence Trap: A History of Democracy in Crisis from World War I to the Present* and *How Democracy Ends*, and he writes regularly about politics for the *London Review of Books*. He is one of the directors of a major Leverhulme-funded research project based in Cambridge on Conspiracy and Democracy, which explores the history and impact of conspiracy theories on democratic politics. He is also the host of the popular weekly podcast *Talking Politics*.

Rosalind ‘Roz’ Savage MBE, an Oxford-educated lawyer, spent the first 11 years of her career working as a management consultant before an environmental epiphany led to her transformation into a world-class adventurer. In the years between 2005 and 2011 Roz rowed, solo, across the Atlantic, Pacific, and Indian Oceans, making her the world’s foremost female ocean rower. On the ocean, Roz had to redefine her comfort zone on a daily basis, and reach deep into her inner sources of strength, self-discipline, and commitment to her goal, as she spent up to 5 months alone at sea on a 23-foot rowboat, thousands of miles from land and humanity, at the mercy of winds, waves, and currents. Roz is a Fellow of the Royal Geographical Society and a Senior Fellow at Yale’s Jackson Institute, where she has taught a course on Courage. She has written two books about her ocean adventures, *Rowing the*

Atlantic and *Stop Drifting Start Rowing*, and she continues to be an advocate for sustainability.

Emily Shuckburgh OBE is a climate scientist and Deputy Head of the British Antarctic Survey's Polar Oceans Team, which focuses on understanding the role of the polar oceans in the global climate system. She holds a doctorate from and a number of positions at the University of Cambridge and is a Fellow of Darwin College. She has worked at Ecole Normal Supérieure and at the Massachusetts Institute of Technology. She is a fellow of the Royal Meteorological Society, where she co-chairs the Climate Science Communications Group, a trustee of the Campaign for Science and Engineering, and a member of the Scientific Steering Committee of the Isaac Newton Institute for Mathematical Sciences. Emily has also acted as an advisor to the UK government on behalf of the Natural Environment Research Council. She co-authored the book *Climate Change* with the Prince of Wales and Tony Juniper, and the Darwin Lecture Series volume on *Survival*.

Nassim Nicholas Taleb spent 21 years as a risk taker before becoming a researcher in philosophical, mathematical, and (mostly) practical problems with probability. He is the author of a multivolume essay, the *Incerto* (*The Black Swan*, *Foiled by Randomness*, *Skin in the Game*, *The Bed of Procrustes: Philosophical and Practical Aphorisms*, and *Antifragile*), exploring the broad facets of uncertainty. His books have been translated into 36 languages. In addition to his life as a trader, Taleb has published, as a backup to the *Incerto*, more than 45 scholarly papers in statistical physics, statistics, philosophy, ethics, economics, international affairs, and quantitative finance, all on the notion of risk and probability. He has spent time as a professional researcher (Distinguished Professor of Risk Engineering at New York University's School of Engineering and Dean's Professor at the University of Massachusetts, Amherst).
