LORENZO BOSI is Associate Professor at the Scuola Normale Superiore (Florence). He is a political sociologist pursuing comparative analysis into the cross-disciplinary fields of social movements and political violence. In his research he is mainly interested in how and when contentious political actors shift their forms of action across time and space. He has published articles in *Historical Sociology*, *Mobilization*, *Qualitative Sociology*, *Social Forces*, *Social Science History* and numerous other academic journals. He is currently exploring the instrumental use of terror in particular during this period.

RORY COX is Senior Lecturer in Medieval History at the University of St Andrews. He is a Fellow of the Royal Historical Society and an Associate Research Fellow of the Handa Centre for the Study of Terrorism and Political Violence (CSTPV). His interdisciplinary research examines violence, the ethics of war and comparative international history over a broad chronological range. He has published on a variety of topics, including ancient just war doctrine, medieval warfare, pacifism and the modern use of torture. He looks to engage different approaches pioneered in the disciplines of History, International Relations, Sociology and Anthropology.

BEATRICE DE GRAAF holds the Chair of History of International Relations and Global Governance at Utrecht University (since February 2014). In December 2019, she was awarded the title of Distinguished Professor. For her research into the history of security and terrorism she won the Stevin Prize (the highest academic distinction in the Netherlands) in 2018. Her book *Fighting Terror after Napoleon: How Europe Became Secure after 1815* was published by Cambridge University Press in 2020. She is currently leading an ERC Consolidator project, 'Securing Europe: The Emergence of a Security Culture in Europe and Beyond after 1815'.

DENNIS DWORKIN is Professor and Chair of the Department of History at the University of Nevada, Reno. He has a PhD in modern history from the

University of Chicago. He is a historian of Britain and Ireland with a specialty in cultural theory and intellectual history. His books include *Cultural Marxism in Postwar Britain: History, the New Left and the Origins of Cultural Studies* (1997), *Class Struggles* (2007) and *Ireland and Britain 1798–1922: An Anthology of Sources* (2012). He has been translated into Chinese, Portuguese and Turkish.

RICHARD ENGLISH is Professor of Politics at Queen's University Belfast. He is the author of eight books, including the award-winning studies *Armed Struggle: The History of the IRA* (2003) and *Irish Freedom: The History of Nationalism in Ireland* (2006). He is a Fellow of the British Academy, a Member of the Royal Irish Academy, a Fellow of the Royal Society of Edinburgh and a Fellow of the Royal Historical Society. In 2018 he was awarded a CBE for services to the understanding of modern-day terrorism and political history.

MARTYN FRAMPTON is Reader in Modern History at Queen Mary University of London. He is the author of three books on Irish Republicanism and 'the Troubles' in Northern Ireland, including *Legion of the Rearguard: Dissident Irish Republicanism* (2011). His most recent book marks a new departure in his research interests and is *The Muslim Brotherhood and the West: A History of Enmity and Engagement* (2018).

DAYYAB GILLANI has a Masters in Politics from the University of Warwick and a PhD in International Relations from the University of St Andrews. He is a fellow of HEC Pakistan and an Associate Fellow of HEA UK. Currently serving as Assistant Professor at the University of the Punjab, his research interests vary from political theory and moral philosophy to political violence and terrorism. Having returned to Pakistan, he has developed a keen interest in the region and has been working strenuously to study and understand the complex nature and history of terrorism and political violence in the country.

STEVE HEWITT is Senior Lecturer in the Department of History at the University of Birmingham in the United Kingdom. FEARGHAL MCGARRY is Professor of Modern Irish History at Queen's University Belfast. He has written widely on modern Ireland, particularly on political violence and radicalism in revolutionary and post-independence Ireland. He is the author of *The Abbey Rebels of 1916: A Lost Revolution* (2015) and *The Rising. Ireland: Easter 1916* (2010). With partners at the University of Edinburgh and Boston College, he is currently leading a major AHRC project, 'A Global History of Irish Revolution, 1916–23', which investigates how the Irish struggle for independence was shaped by international currents. His next book will explore anxieties about modernity in interwar Ireland.

LUDGER MEES completed his PhD in History at the University of Bielefeld (Germany) and was Assistant Professor at the same institution before taking up a Lectureship at the University of the Basque Country (Bilbao, Spain) in 1991. Since 2004 he has been Full Professor of Contemporary History at the University of the Basque Country and during 2004–9 he was also Vice-Chancellor. He is author, co-author or editor of twenty books and about 120 articles and book chapters in the fields of nationalism, social movements, historiography and agrarian history. One of his most recent books is *The Basque Contention: Ethnicity, Politics, Violence* (2020).

CECILIA MÉNDEZ is Associate Professor in the Department of History and Director of the Program in Latin American and Iberian Studies at the University of California Santa Barbara. She is a Peruvian historian specialising in the social and political history of the Andean region. She holds a PhD from the State University of New York, Stony Brook, and her publications include *The Plebeian Republic: The Huanta Rebellion and the Making of the Peruvian State, 1820–1850* (2005), which won the Howard F. Cline Award for the best book published on indigenous history in Latin America. Her work emphasises the importance of late eighteenth-century and nineteenth-century political developments in shaping modern conceptions of nationhood, citizenship and race.

RORY MILLER is a Professor of Government at Georgetown University in Qatar. Previously, he served in the War Studies Department and as head of the Middle East Program at King's College London. He is co-editor of the

A native of Washington, DC, she has a PhD in International Relations from American University.

RICHARD REID is Professor of African History in the Faculty of History and a Fellow of St Cross College at the University of Oxford. His work has focused particularly on the history of political culture, historical consciousness, warfare and militarism in Africa, notably eastern and north-east Africa, including Eritrea, Ethiopia, Uganda and Tanzania.
