

The Cambridge Companion to **Pufendorf**

In the same intellectual league as Grotius, Hobbes and Locke, but today less well known, Samuel Pufendorf was an early modern master of political, juridical, historical and theological thought. Trained in an erudite humanism, he brought his copious command of ancient and modern literature to bear on precisely honed arguments designed to engage directly with contemporary political and religious problems. Through his fundamental reconstruction of the discipline of natural law, Pufendorf offered a new rationale for the sovereign territorial state, providing it with non-religious foundations in order to fit it for governance of multi-religious societies and to protect his own Protestant faith. He also drew on his humanist learning to write important political histories, a significant lay theology and vivid polemics against his many opponents. This volume makes the full scope of his thought and writing accessible to English readers for the first time.

Knud Haakonssen has studied the diaspora of modern natural law, its adaptation as moral philosophy and its academic institutionalization in various European contexts. Contributors

Thomas Ahnert is Professor of Intellectual History at the University of Edinburgh. He has published on a range of topics in European intellectual history from the mid-seventeenth century to the early nineteenth. His works include *Religion and the Origins of the German Enlightenment: Faith and the Reform of Learning in the Thought of Christian Thomasius* (2006) and *The Moral Culture of the Scottish Enlightenment, 1690–1805* (2014), as well as a collection of essays, co-edited with Susan Manning, *Character, Self and Sociability in the Scottish Enlightenment* (2011).

Knud Haakonssen is Professor of Intellectual History (part-time) at the University of St Andrews, Professor Emeritus at the University of Sussex and Adjunct Professor at the University of Copenhagen. He is a Fellow of the British Academy. His publications on modern moral and political thought include *Natural Law and Moral Philosophy* (1996) and, as editor, *The Cambridge History of Eighteenth-Century Philosophy* (2006). He is completing a new edition of the eighteenth-century translation of Pufendorf's *The Law of Nature and Nations*.

Ian Hunter is Emeritus Professor at the Institute for Advanced Studies in the Humanities at the University of Queensland. His published works include *Rival Enlightenments: Civil and Metaphysical Philosophy in Early Modern Germany* (2001) and various writings on the history of philosophical, theological and political thought. He is presently completing a book on Kant's religious philosophy.

Mads Langballe Jensen is a postdoctoral fellow at the Saxo Institute, University of Copenhagen. He has published on the history of natural law from the sixteenth to the eighteenth century. His first book is *A Humanist in Reformation Politics: Philipp Melanchthon on Political Philosophy and Natural Law* (2020). His second book, under preparation, will deal with the

uses of the law of nature and nations in Danish colonialism in the Atlantic c. 1660–1850.

Sebastian Olden-Jørgensen is Professor of Modern History at the University of Copenhagen. He has written extensively on court history, the history of learning and the history of religious and political thought in Danish and European contexts 1500–1700, including essays on Samuel Pufendorf and his elder brother, Esaias. Together with Knud Haakonssen he edited and contributed to *Ludvig Holberg (1684–1754)*. *Learning and Literature in the Nordic Enlightenment* (2017).

Fiammetta Palladini, prior to her retirement, was Primo ricercatore at the National Council for Research, Rome, based in Berlin. She has published several books and many papers on Samuel Pufendorf, on Jean Barbeyrac and on seventeenth-century moral and political philosophy. These include Discussioni seicentesche su Samuel Pufendorf (1978), Samuel Pufendorf discepolo di Hobbes (1990; English translation 2020), La biblioteca di Samuel Pufendorf (1999), Die Berliner Huguenotten und der Fall Barbeyrac (2011) and Actes du Consistoire de l'Église Française de Berlin (1672–1694) (critical edition, 2022).

Pärtel Piirimäe is Professor of Intellectual History at the University of Tartu, Estonia. His recent publications include 'Men, monsters, and the history of mankind in Emer de Vattel's *Law of Nations*', 'Official historiography and the state in Early Modern Europe', 'Philosophical disputations at the University of Tartu 1632–1710' and 'Livonian *Vaterland* and Swedish *Landesvater*: languages of patriotism in the seventeenth-century Swedish empire'.

Michael Seidler is University Distinguished Professor of Philosophy at Western Kentucky University. Beside articles and chapters on many aspects of Pufendorf and early modern natural law, he has translated and edited several works by Pufendorf, including *The Political Writings of Samuel Pufendorf* (Oxford, 1994). His current projects include an edition of Pufendorf's *Dissertationes academicae selectiores*, one of the final volumes to be included in *Gesammelte Werke* (Berlin, 1996–).

Walter Sparn is Professor Emeritus of Systematic Theology and Philosophy of Religion at Friedrich-Alexander-Universität Erlangen-Nürnberg. His main field of research has been the interrelations of scholarly and religious

dynamics between P. Melanchthon and I. Kant. He is co-editor of *Neue Zeitschrift für Theologie und Religionsphilosophie* and was responsible for 'Religious Cultures' in the dimensions of intellectual, moral and aesthetic life in *Enzyklopädie der Neuzeit* (12 vols., 2005–12). At the moment he is copreparing a *Brill Companion to Early Lutheranism* (forthcoming end of 2022), to which he is contributing articles on methodology, anthropology, hermeneutics and the Enlightenment.

Joachim Whaley is Emeritus Professor of German History and Thought at the University of Cambridge, a Fellow of Gonville and Caius College, and a Fellow of the British Academy. He is the author of *Germany and the Holy Roman Empire*, 2 vols. (Oxford, 2012) and many other writings on German history and ideas from the late Middle Ages to the present.

Simone Zurbuchen is Professor of Modern and Contemporary Philosophy at the University of Lausanne. She has written widely on Pufendorf and the Swiss school of natural law. She edited Pufendorf's writings on religion and toleration, *Of the Nature and Qualification of Religion, in Reference to Civil Society* (2002) and *The Divine Feudal Law: Or, Covenants with Mankind, Represented* (2002). She has also edited *The Law of Nations and Natural Law, 1625–1800* (2019).
