This book will be an indispensable reading for scholars and practitioners with an interest in China and international dispute resolution. It also constitutes an invaluable reference for anyone interested in the changing international law and order, in which China is playing an increasingly significant role, particularly through the BRI construction.

WENHUA SHAN (PhD, Trinity College, Cambridge) is Ministry of Education Yangtze River Chair Professor of International Economic Law and the founding Dean of the School of Law at Xi'an Jiaotong University, PR China. He is also the founding Director of the Silk Road Institute for Interactional and Comparative Law (SRIICL). He has taught as Professor of International Law at Oxford Brookes University and UNSW Sydney, and has been a Senior Fellow of the Lauterpacht Centre for International Law at the University of Cambridge, Assistant President, Xi'an Jiaotong University, and Deputy Director-General of the Judicial Case Academy at the Supreme People's Court, PR China. He has published over a dozen books in international and comparative law with leading English and Chinese publishers, including CUP and OUP, and numerous articles in journals such as the European Journal of International Law and American Journal of Comparative Law. He is the founding Editor-in-Chief of The Chinese Journal of Comparative Law and founding General Editor of the "China and International Economic Law Series" and "Silk Road Studies in International Economic Law". As Conciliator of the International Centre for the Settlement of Investment Disputes (ICSID), Expert Member of the International Commercial Expert Committee of the Supreme People's Court of China, Executive President of the China International Investment Arbitration Forum (CIIAF) and Arbitrator of the China International

Economic and Trade Arbitration Commission (CIETAC) among others, Shan has practised international and Chinese laws since 1992.

SHENG ZHANG is Associate Professor at Xi'an Jiaotong University School of Law. He is Deputy Secretary-General of the China International Investment Arbitration Forum and an editor of *The Chinese Journal of Comparative Law*. He mainly focuses on international investment law and comparative law. He was a visiting scholar at the Lauterpacht Centre for International Law and the Max-Planck Institute for Comparative and International Private Law. He has published articles in the *European Journal of International Law*, *Journal of International Dispute Settlement*, *The Chinese Journal of Comparative Law* and *Columbia FDI Perspectives*.

JINYUAN SU is Professor of International Law at Xi'an Jiaotong University School of Law. He was an Erin J. C. Arsenault Fellow (2014–2015) at the McGill Institute of Air and Space Law and a visiting research fellow (2009–2010) at the Lauterpacht Centre for International Law, University of Cambridge. Dr Su's research interests lie in outer space law, the law of the sea and international aviation law. His articles are published in international peer-reviewed journals such as Chinese Journal of International Law, International & Comparative Law Quarterly, Asian Journal of International Law, Ocean Development & International Law and The International Journal of Marine and Coastal Law.

JUDGE JAMES RICHARD CRAWFORD is currently a member of the International Court of Justice. Prior to his election to the Court, he acted as counsel in numerous cases before the International Court of Justice and other international tribunals, and as an arbitrator in twenty-six international arbitrations. He was Whewell Professor of International Law at the University of Cambridge and has published widely in the fields of statehood, collective rights, investment law and international responsibility. Recent works include The International Law of Responsibility (coedited, OUP, 2010), The Cambridge Companion to International Law (coedited, CUP, 2012) and Brownlie's Principles of Public International Law (9th edition, OUP, 2019). He was the first Australian member of the United Nations International Law Commission and in that capacity was responsible for the ILC's work on the International Criminal Court (1994) and for the second reading of the ILC Articles on State Responsibility (2001). He has been Yangtze River Chair Professor of International Law (by Ministry of Education) and the Honorary Director of the Silk Road Institute for International and Comparative Law of XJTU.

MICHAEL HWANG currently practises as a barrister, primarily servicing lawyers as independent counsel and arbitrator. He has received specialist training in both domestic and international arbitration (as well as mediation), and has lectured and written extensively on international arbitration and mediation. He is active in domestic and international disputes (under ICC, CIETAC, UNCITRAL, LCIA, ICSID, AAA, BANI and SIAC Rules) as counsel and arbitrator as well as mediator. His arbitrations and mediations have involved disputes in a host of countries all over the world. He is an accredited arbitrator to sixteen national arbitration centres as well as the Permanent Court of Arbitration and ICSID. Dr Hwang received his legal education at Oxford University (both at undergraduate and postgraduate levels) where he was a College Scholar and prizewinner. He then took up a teaching appointment at the Faculty of Law at the University of

Sydney before returning to Singapore to commence private practice in 1968. In 1991, Dr Hwang was appointed a Judicial Commissioner of the Supreme Court (a full time post equivalent to the office of an acting High Court Judge) for a fixed term which expired at the end of 1992. He returned to private practice at the beginning of 1993, and was Head of the Litigation Department of the law firm of Allen & Gledhill, Singapore (currently Singapore's largest law firm). He retired from the firm at the end of 2002 to establish an independent practice as a barrister and chartered arbitrator. In 1997, Dr Hwang was appointed one of the first twelve Senior Counsel of the Supreme Court of Singapore (an appointment equivalent to that of Queen's Counsel in England). He has (at different times) acted as Visiting Professor as well as Adjunct Professor at the National University of Singapore, and has been conferred with an Honorary LLD Degree by the University of Sydney.

- LIM SI CHENG is an Associate in the International Arbitration practice of Mayer Brown's Singapore office. He is a former Associate at Michael Hwang Chambers, and an LLB (Hons) graduate from Durham University.

more than thirty-five years. He has been a secretary, member or chairman of GATT/WTO dispute settlement panels and chaired the International Trade Law Committee of the International Law Association from 1999 to 2014. He has published 30 books and more than 300 contributions to books and journals on international law. He is Emeritus Professor of international and European law and former head of the Law Department at the European University Institute, Florence (Italy).

GUOHUA YANG is a professor at Tsinghua University Law School. He worked in the Chinese Ministry of Commerce from 1996 to 2014; he was the first Director and later Deputy Director General for WTO Legal Affairs within the Ministry responsible for WTO cases related to China. He also has a rich background on trade policy making and international cooperation. For example, he was the head of Chinese delegations for intellectual property rights dialogues with the United States, the EU, Japan, Russia, Switzerland and Brazil, and for international conferences at Asia-Pacific Economic Cooperation (APEC) and United Nations Commission on International Trade Law (UNCITRAL), etc. He is Executive Vice Chairman, WTO Law Research Society of China Law Society (China WTO Law Society); Arbitrator, International Economic and Trade Arbitration Commission (CIETAC, China) and South China International Economic and Trade Arbitration Commission/Shenzhen Court of International Arbitration (SCIA, China); Member, Expert Group for Commercial and Maritime Trials, Supreme Court, China; Member, Indicative List for dispute settlement panels, WTO Secretariat; Associate Editor, Journal of World Trade; Distinguished Legal Scholar Award, Beijing Law Society (1999). He was also IP attaché at the Chinese Embassy in the United States, Washington, DC (January 2006-September 2008). He graduated from Peking University Law School in 1996 (PhD) and Wuhan University Law School in 1994 (LLM).

MEG KINNEAR is currently the Secretary-General of the International Centre for Settlement of Investment Disputes (ICSID) at the World Bank. She was formerly the Senior General Counsel and Director General of the Trade Law Bureau of Canada, where she was responsible for the conduct of all international investment and trade litigations involving Canada, and participated in the negotiations of bilateral investment agreements. ANATOLE BOUTE is a professor at the Chinese University of Hong Kong, specializing in the fields of energy, environmental and investment law. His research focuses on the legal aspects of the transition of energy systems towards sustainability, with a special interest for energy market reforms in emerging economies.
