

The Grammar of Time

Kreuzer offers guidance to scholars looking to comparative historical analysis (CHA) for the tools to analyze macro-historical questions. Like history, CHA uses the past to formulate research questions, describe social transformations, and generate inductive insights. Like social science, CHA compares those patterns to explicate generalizable and testable theories. It operates in two different worlds – one constantly changing and full of cultural particularities, another static and full of orderly uniformities. CHA draws attention to the ontological constructions of these worlds; how scholars background historical and geographic particularities to create a social reality orderly enough for theorizing, while others foreground those particularities to re-complexify it and generate new inductive insights. CHA engages in ontological triage, dialogue between exploration and confirmation, and conversation on how to translate test results into genuine answers. This book is supplemented by online materials that include a glossary, diagnostic quizzes, advanced exercises, and annotated bibliography.

Marcus Kreuzer is Professor of Political Science at Villanova University. His research builds a bridge between the worlds of history and social science methodology. His earlier research focused on the nineteenth-century origins of modern democracy and the role party systems played in the consolidation of interwar and post-communist democracies. His subsequent work on comparative historical methodology has won several best paper awards from the American Political Science Association. He also regularly teaches CHA at various methods schools.

Acknowledgments

Writing this book was a humbling experience, as it made me realize how much I depended on others to help me articulate my thoughts. My thanks are therefore numerous.

Several books – exploring the outer perimeters of social science methodology – helped me situate comparative historical analysis (CHA). Stephen Kern’s *Culture of Time and Space, 1880–1919* (1983) and *Cultural History of Causality* (2004) discuss the historical construction of time, space, and causality – three building blocks of CHA – thus offering a counterpoint to their otherwise often reified treatment in standard textbooks. Howard Becker’s *Tricks of the Trade* (1998) and *Telling about Society* (2007), Andrew Abbott’s *Methods of Discovery* (2004) and *Digital Paper* (2016), Stuart Firestein’s *Ignorance* (2012) and *Failure* (2015), and Giovanni Sartori’s writings (1970) on conceptualization explore the messier and more exploratory aspects of social inquiry. They recognized that sleuthing is required to discover new evidence, that closely parsing texts helps develop clearer concepts, and that a dose of adventurism is indispensable to escape from the cul-de-sacs into which research invariable lures scholars. Most importantly, they celebrate those messier elements of social inquiry as being essential to engage with the real world. They stand for a more pragmatic, less math-centered, maybe even older, but increasingly marginalized understanding of social science that has, thank God, survived and flourishes in CHA.

Turning the broad inspiration these books provided into practical research advice required integrating insights from far-flung literatures and navigating a messy terminological terrain. Not surprisingly, my drafts took many wrong turns, were too snarky in tone, and would never have progressed were it not for the kindness, generosity, and thoughtfulness of many colleagues.
