Volume I of *The Cambridge History of Global Migrations* documents the lives and experiences of everyday people through the lens of human movement and mobility from 1400 to 1800. Focusing on the most important typologies of preindustrial global migrations, this volume reveals how these movements transformed global paths of mobility, the impacts of which we still see in societies today. Case studies include those that arose from the demand for free, forced, and unfree labor, long- and short-distance trade, rural/urban displacement, religious mobility, and the rise of the number of refugees worldwide. With thirty chapters from leading experts in the field, this authoritative volume is an essential and detailed study of how migration shaped the nature of global human interactions before the age of modern globalization.

CÁTIA ANTUNES is Professor of History and Global Economic Networks at Leiden University. She has published, edited, and translated monographs and articles on the exploitation of early modern empires and the transition from colonialism to imperialism. She is co-editor, with Francisco Bethencourt, of *Merchant Cultures: A Global Approach to Spaces, Representations and Worlds of Trade, 1500–1800*.

ERIC TAGLIACOZZO is John Stambaugh Professor of History at Cornell University, where he is the director of the Comparative Muslim Societies Program. His book *Secret Trades, Porous Borders: Smuggling and States along a Southeast Asian Frontier, 1865–1915* won the Harry Benda Prize from the Association for Asian Studies (AAS).

SEEMA ALAVI is Professor of History at Ashoka University in Sonapat, Haryana. She specializes in medieval and early modern South Asia, with an interest in the transformation of the region's legacy from Indo-Persian to one heavily affected by British colonial rule.

FRANCIS R.
