## PLAYING AND PLAYGOING IN EARLY MODERN ENGLAND

This edited collection of essays brings together leading scholars of early modern drama and playhouse culture to reflect upon the study of playing and playgoing in early modern England. With a particular focus on the player–playgoer exchange as a site of dramatic meaning-making, this book offers a timely and significant critical intervention in the field of Shakespeare and early modern drama. Working with and reflecting upon approaches drawn from literary scholarship, theatre history and performance studies, it seeks to advance the critical conversation on the interactions between: players; play-texts; performance spaces; the bodily, sensory and material experiences of the playhouse; and playgoers’ responses to, and engagements with, the theatre. Through alternative methodological and theoretical approaches, previously unknown or overlooked evidence and fresh questions asked of long-familiar materials, the volume offers a new account of early modern drama and performance that seeks to set the agenda for future research and scholarship.

SIMON SMITH is Associate Professor of Shakespeare and Early Modern Drama at the Shakespeare Institute, Stratford-upon-Avon, and the Department of English Literature, University of Birmingham. He researches early modern drama, music and sensory culture. He is the author of *Musical Response in the Early Modern Playhouse, 1603–1625* (Cambridge University Press, 2017), for which he won the Shakespeare’s Globe Book Award and the University English Book Prize. He edited *Shakespeare/Sense* (Arden, 2020) and, with Jackie Watson and Amy Kenny, *The Senses in Early Modern England, 1558–1660* (Manchester University Press, 2015). He has acted as a historical music and theatre consultant to the RSC, Shakespeare’s Globe, the *Independent* and the BBC adaptation of *Wolf Hall*.

EMMA WHIPDAY is Lecturer in Renaissance Literature at Newcastle University. She researches domestic violence, gender and power, familial structures and performance in and beyond the playhouse. Her monograph, *Shakespeare’s Domestic Tragedies: Violence in the Early Modern Home* (Cambridge University Press, 2019), won the 2020 Shakespeare’s Globe Book Award. She is currently working on a Leverhulme-funded book on brother–sister relationships on the early modern stage. Emma regularly directs ‘practice as research’ stagings of early modern texts. She also writes plays, including *Shakespeare’s Sister* (Samuel French, 2016) and *The Defamation of Cicely Lee* (2019), winner of the American Shakespeare Center’s ‘Shakespeare’s New Contemporaries’ award.

## *Notes on Contributors*

**Helen Hackett** is Professor of English Literature at University College London, where she co-founded the UCL Centre for Early Modern Exchanges. She has published widely on early modern literature and drama, including the introduction to the Penguin edition of *A Midsummer Night's Dream* (2005), *Shakespeare and Elizabeth: The Meeting of Two Myths* (Princeton University Press, 2009) and *A Short History of English Renaissance Drama* (I.B. Tauris, 2013). She is currently completing *The Elizabethan Mind*, a Leverhulme-funded study of late sixteenth-century theories of the mind and how they influenced the literary innovations of the period. This includes a chapter on Elizabethan concepts of, and attitudes to, the imagination, which intersects with her essay for the present volume.

**Farah Karim-Cooper** is Professor of Shakespeare Studies, King's College London, and Co-Director of Education at Shakespeare's Globe, where she has worked for the last sixteen years. Farah is President of the Shakespeare Association of America, 2021–2022. She is on the Advisory Council for the Warburg Institute and has held Visiting Fellowships around the world. She leads the architectural enquiries into early modern theatres at Shakespeare's Globe, overseeing the research into the design and construction of the Sam Wanamaker playhouse, the Globe's indoor Jacobean theatre. She has published over forty chapters in books, reviews and articles and is General Editor for Arden's Shakespeare in the Theatre series and their Shakespeare Intersections series. She has written two books: *Cosmetics in Shakespearean and Renaissance Drama* (Edinburgh University Press, 2006, revised ed. 2019) and *The Hand on the Shakespearean Stage: Gesture, Touch and the Spectacle of Dismemberment* (Arden, 2016). She has also co-edited *Shakespeare's Globe: A Theatrical Experiment* with Christie Carson (Cambridge University Press, 2008); *Shakespeare's Theatres and the Effects of Performance* with Tiffany Stern (Arden, 2013);



and *Moving Shakespeare Indoors: Performance and Repertoire in the Jacobean Playhouse* with Andrew Gurr (Cambridge University Press, 2014). She recently edited a collection for Arden, *Titus Andronicus: The State of Play* (2019) and has edited John Webster's *The Duchess of Malfi* for the *Routledge Anthology of Early Modern Drama*, edited by Jeremy Lopez (2020). She is currently writing a book on Shakespeare and Race. In 2018, she curated the Globe's first Shakespeare and Race Festival and leads the Globe's Anti-racist Action Group. She is an executive board member for RaceB4Race, a consortium of scholars and institutions that seek racial justice in the field of pre-modern literary studies. In the UK, she is creating the first ever Scholars of Colour network.

**Natasha Korda** is Director of the Center for the Humanities and Professor of English at Wesleyan University and was the 2020–1 President of the Shakespeare Association of America. She is author of *Shakespeare's Domestic Economies: Gender and Property in Early Modern England* (University of Pennsylvania Press, 2002) and *Labor Lost: Women's Work and the Early Modern English Stage* (University of Pennsylvania Press, 2011), and co-editor of *Staged Properties in Early Modern English Drama* (Cambridge University Press, 2002) and *Working Subjects in Early Modern English Drama* (Routledge, 2011). She is currently editing the Norton Critical Edition of Shakespeare's *Twelfth Night* and writing a book on material ephemera and early modern theatre historiography.

**Jeremy Lopez** is Professor of English at the University of Toronto and the editor of *Shakespeare Quarterly*. He is the author of numerous books and essays on the drama of Shakespeare and his contemporaries and General Editor of the *Routledge Anthology of Early Modern Drama* (2020).

**Lucy Munro** is Professor of Shakespeare and Early Modern Literature at King's College London. She is author of *Children of the Queen's Revels: A Jacobean Theatre Repertory* (Cambridge University Press, 2005), *Archaic Style in Early Modern Literature, 1590–1674* (Cambridge University Press, 2013) and *Shakespeare in the Theatre: The King's Men* (Arden, 2020), as well as editor of plays including Dekker, Ford and Rowley's *The Witch of Edmonton* (Arden Early Modern Drama, 2016).

**Eoin Price** is Senior Lecturer in English Literature at Swansea University. He is the author of *'Public' and 'Private' Playhouses in Renaissance England* (Palgrave, 2015), and his work on theatre history, book history and contemporary performance has appeared in *Shakespeare Survey*, *Shakespeare Bulletin* and *Early Theatre*. A version of his chapter in this

collection was awarded the 2020 Calvin and Rose G. Hoffman Prize for Distinguished Publication on Christopher Marlowe.

**Stephen Purcell** is Associate Professor of English at the University of Warwick. His research focuses on Shakespeare in contemporary performance and popular culture. His publications include *Popular Shakespeare* (Palgrave, 2009), *Shakespeare and Audience in Practice* (Palgrave, 2013) and numerous articles on Shakespeare on stage, television and film. He has published in *Shakespeare*, *Shakespeare Bulletin*, *Shakespeare Jahrbuch* and *Shakespeare Survey*. His most recent book is *Shakespeare in the Theatre: Mark Rylance at the Globe* (Arden, 2016). He is Joint Artistic Director of the theatre company The Pantaloons and frequently leads practice-as-research workshops with the company at conferences and elsewhere.

**Simon Smith** is Associate Professor of Shakespeare and Early Modern Drama at the Shakespeare Institute, Stratford-upon-Avon and the Department of English Literature, University of Birmingham. He researches early modern drama, music and sensory culture. His monograph, *Musical Response in the Early Modern Playhouse, 1603–1625* (Cambridge University Press, 2017), won the Shakespeare's Globe Book Award and the University English Book Prize. Other publications include two edited collections, *The Senses in Early Modern England, 1558–1660* (Manchester University Press, 2015; with Jackie Watson and Amy Kenny) and, for the Arden Shakespeare Intersections series, *Shakespeare/Sense* (Arden, 2020). His current book project, funded by the Leverhulme Trust, examines playgoing, pleasure and judgement in early modern England.

**Tiffany Stern**, FBA, is Professor of Shakespeare and Early Modern Drama at the Shakespeare Institute, University of Birmingham. Her books are *Rehearsal from Shakespeare to Sheridan* (Oxford University Press, 2000), *Making Shakespeare* (Routledge, 2004), *Shakespeare in Parts* (with Simon Palfrey, Oxford University Press, 2007) and *Documents of Performance in Early Modern England* (Cambridge University Press, 2009). She has edited five plays, put together two scholarly editions and written over sixty chapters and articles on sixteenth- to eighteenth-century drama, Shakespeare, theatre history, book history and editing. General Editor of New Mermaids Plays and Arden Shakespeare 4, her current projects are a book on Shakespeare's product placement and an Arden 4 edition of *The Tempest*. She was elected Fellow of the British Academy in 2019.

**Jackie Watson** holds a PhD from Birkbeck, University of London, where she has also worked as an associate tutor in the Department of English and Humanities.
