The subject of religious diversity is of growing significance, with its associated problems of religious pluralism and interfaith dialogue. Moreover, since the European Enlightenment, religions have had to face new, existential challenges. Is there a future for religions? How will they have to change? Can they co-exist peacefully? In this book, Keith Ward brings new insights to these questions. Applying historical and philosophical approaches, he explores how we can establish truth among so many diverse religions. He explains how religions have evolved over time and how they are reacting to the challenges posed by new scientific and moral beliefs. A celebration of the diversity in the world's religions, Ward's timely book also deals with the possibility and necessity of religious tolerance and co-existence.

KEITH WARD is Professor of Religious Studies at University of Roehampton, London. A Fellow of the British Academy, he was Regius Professor of Divinity at Oxford University and served as President of the World Congress of Faiths. He is the author of numerous books; most recently, *Christ and the Cosmos* (2015) and *The Christian Idea of God* (2015), both published by Cambridge University Press.
