The Past Can't Heal Us

In this innovative study, Lea David critically investigates the relationship between human rights and memory, suggesting that, instead of understanding human rights in a normative fashion, human rights should be treated as an ideology. Conceptualising human rights as an ideology gives us useful theoretical and methodological tools to recognise the real impact human rights has on the ground. David traces the rise of the global phenomenon that is the human rights memorialisation agenda, termed 'moral remembrance', and explores what happens once this agenda becomes implemented. Based on evidence from the Western Balkans and Israel/Palestine, she argues that the human rights memorialisation agenda does not lead to a better appreciation of human rights; instead, contrary to what would be expected, it serves to strengthen national sentiments, divisions and animosities along ethnic lines, and leads to the new forms of societal inequalities that are closely connected to different forms of corruptions.

LEA DAVID is Assistant Professor and Ad Astra Fellow at the School of Sociology, University College Dublin. She has held the prestigious Fulbright, Jonathan Shapira and Marie Curie postdoctoral fellowships and established the Critical Thinking on Memory and Human Rights Research Group.
