

BENJAMIN BRITTEN IN CONTEXT

The contexts for Benjamin Britten's music, life, and work are explored in forty curated chapters by thirty-one authors whose areas of expertise encompass art, sociocultural, and music history and theory, performance, religion, and literature. Collated broadly, they offer an historically motivated illumination for discrete yet interlocking aspects of his existence. The prologue situates the composer in relation to society; the epilogue reconsiders Britten's influence beyond 1976. A list of sources offers both references cited and recommendations for further reading. We approached Britten's milieu from vantage points that could adequately represent the fullness of his position in England and in the twentieth century. We were rewarded by the richness of Britten's engagement with his contemporaries in music, art, literature, and film, British musical institutions, royal and governmental entities, and the church. Equally, his groundbreaking projects, which intersected across diverse entities and explored his philosophical and ideological tenets, provided food for thought. Although standard biographies examine their subjects from within, this series examines the subject from without. In pursuit of understanding this composer, we offer five major areas of inquiry: Britten's relationship with Peter Pears, and with his close friends, mentors, and colleagues; musical life in Britain; his interactions with previous and contemporary generations of composers; his choreographer, librettists, stage designers, and directors; and lastly, the sociocultural, religious, and political era in which he lived and composed. The ensuing chapters are flint, of sorts, to spark the reader's own exploration of each of the varied contexts surrounding Britten presented herein.

VICKI P. STROEHER is Professor of Music at Marshall University in Huntington, West Virginia. She is the co-editor of *My Beloved Man: The Letters of Benjamin Britten and Peter Pears*, with Jude Brimmer and Nicholas Clark (2016), which earned the 2017 C. B. Oldman Award (IAML–UK and Ireland) and *Benjamin Britten Studies: Essays on An Inexplicit Art* (2017), co-edited with Justin Vickers. She has also contributed to *Literary Britten*. Her current research project is a monograph on Britten's songs (Boydell, forthcoming).

JUSTIN VICKERS is Professor of Music at Illinois State University. As a US Fulbright Scholar to the United Kingdom, he is completing his first monograph *The Aldeburgh Festival of Music and the Arts: A History of the Britten and Pears Era, 1948–1986*, forthcoming by The Boydell Press. He is co-editor of *Benjamin Britten Studies: Essays on An Inexplicit Art* (2017) with Vicki P. Stroeher. He has contributed to *The Sea in the British Musical Imagination* (2016) and *Literary Britten: Words and Music in Benjamin Britten's Vocal Works* (2019). His additional research focuses on Britten's song and the creative process, Peter Pears, and the English Opera Group, among other midcentury topics in the British Isles.

Understanding and appreciation of musical works is greatly enhanced by knowledge of the context within which their composers lived and worked. Each of these volumes focusses on an individual composer, offering lively, accessible and concise essays by leading scholars on the many contexts – professional, political, intellectual, social and cultural – that have a bearing on his or her work. Biographical and musical influences, performance and publishing history and the creative afterlife of each composer's work are also addressed, providing readers with a multifaceted view of how the composers' output and careers were shaped by the world around them.

ARVED ASHBY is Professor of Music and head of the musicology area in the School of Music at the Ohio State University. He has published books on modernism, film music and recent *auteurisme*, and the idea of absolute music as it ultimately came to dovetail with media developments in the twentieth century (*Absolute Music, Mechanical Reproduction*, University of California, 2010). Published essays focus on Alban Berg, Arnold Schoenberg, Frank Zappa, and Britten. His most recent publication is the general-readership volume *Experiencing Mahler: A Listener's Companion* (Rowman & Littlefield, 2020).

JOANNA BULLIVANT is Departmental Lecturer in Historical Musicology at the University of Oxford. She has published widely on aspects of British music and politics, including essays on Alan Bush, Britten, Tippett, and Eisler. Her book, *Alan Bush, Modern Music and the Cold War: The Cultural Left in Britain and the Communist Bloc*, was published by Cambridge University Press in 2017.

MICHAEL BURDEN is Professor in Opera Studies at the University of Oxford, where he is also Dean of New College. His published research is on the stage music of Henry Purcell and its later reuse and reinterpretation, and on aspects of London dance and theatre in the seventeenth, eighteenth, and nineteenth centuries; it includes a study of the London years of the soprano Regina Mingotti.

NICHOLAS CLARK is Librarian for Britten Pears Arts, based at The Red House, Aldeburgh, where he has supervised the cataloguing of Britten and Pears's original book collection. His previous research interests include work on the artist David Myerscough-Jones and his set designs for Britten's operas, the history of The Red House Library and Archive collections, and the various literary influences on Britten's music.

MERVYN COOKE is Professor of Music at the University of Nottingham. His books on Britten include *Britten and the Far East* (Boydell, 1998), *The Cambridge Companion to Benjamin Britten* (Cambridge University Press, 1999), four co-edited volumes of the composer's correspondence, and studies of *Billy Budd* (Cambridge University Press, 1993) and *War Requiem* (Cambridge University Press, 1996). He has also published widely in the fields of film music and jazz and is co-editor of *The Oxford Handbook of Shakespeare and Music* (Oxford University Press, 2022).

ALAIN FROGLEY is Professor of Music and Associate Dean in the School of Fine Arts at the University of Connecticut. He has also taught at Oxford, Lancaster, and Yale universities, and in 2005–6 was a Fellow of the American Council of Learned Societies. He has written extensively on British music and on Beethoven, focusing on sketch studies, reception history, and the cultural contexts of musical nationalism, including imperialism and the modern metropolis.

ALISON GARNHAM is a cultural historian and the biographer of Hans Keller. Her books include *Hans Keller 1919–1985: A Musician in Dialogue with His Times* (Routledge, 2019). She has worked extensively on the history of broadcasting, including the Proms, the European Broadcasting Union, the Third Programme and the legacy of William Glock. She is currently Visiting Research Fellow at Goldsmiths, University of London.

KATE GUTHRIE is a lecturer in music at the University of Bristol, specialising in the social, political, and cultural history of music in twentieth-century Britain. She is the author of *The Art of Appreciation: Music and Middlebrow Culture in Modern Britain* (University of California Press, 2021) and editor of the *Oxford Handbook to Music and the Middlebrow*, and has published award-winning articles in the *Journal of the Royal Musical Association* and *Music & Letters*.

J. P. E. HARPER-SCOTT is Emeritus Professor of Music History and Theory at Royal Holloway, University of London, and General Editor of the Cambridge University Press series, 'Music in Context'. His work focuses on an examination of music's cultural, personal, and interpersonal significance since around 1800. It draws extensively on philosophical, cultural, and social theory and the explanatory resources of music theory, and espouses an explicitly Leftist perspective. He is the author of numerous books and articles, including *The Event of Music History* (Boydell, 2021), *Ideology in Britten's Operas* (Cambridge University Press, 2018), *The*

MARGARET LANE trained as a barrister before pursuing her theological and spiritual interests. She gained a postgraduate diploma in religious studies and an MA in Patristics from King's College, London, and a PhD in the mystical theology of St. Augustine from the University of Durham. She now writes and speaks on Christian spirituality as an independent scholar.

CHRISTOPHER MARK is a senior lecturer in musicology at the University of Surrey. She is author of *Bergson in Britain: Modern Art and Philosophy c. 1890–1914* (Edinburgh University Press, 2021) and co-editor with Sarah Mahler Kraaz of *The Bloomsbury Handbook to Music and Art* (2022).

IRENE MORRA is Professor of English Literature at Cardiff University. She is the author of *Twentieth-Century British Authors and the Rise of Opera in Britain* (Routledge, 2007); *Britishness, Popular Music, and National Identity: The Making of Modern Britain* (Routledge, 2014); and *Verse Drama in England, 1900–2015* (Bloomsbury, 2016), and is the co-editor of a study of New Elizabethanism in the arts. Her research typically focuses on interdisciplinary aesthetics across the arts, on aesthetic manifestations of cultural nationalism, and on intermediality.

JULIAN ONDERDONK is a music historian specialising in twentieth-century British culture and society. A particular interest is the interaction of vernacular and art music traditions and their impact on ideas of national identity. IAN PATTERSON, after working in further education and as a translator and secondhand bookseller, taught English for twenty years at Queens' College, Cambridge, where he is now a Life Fellow. He has published extensively on writers of the interwar period, including *Guernica and Total War* (Profile/Harvard University Press, 2007); translated the final volume of Proust's *In Search of Lost Time* (Penguin, 2003); and has published over a dozen books of poetry. He lives in Suffolk.

CAMERON PYKE read history at Sidney Sussex College, Cambridge and later studied Benjamin Britten's creative relationship with Russia at Goldsmiths, University of London, under Professor Alexander Ivashkin. His book *Benjamin Britten and Russia* (Aldeburgh Studies in Music) was published by the Boydell Press in 2016. He has a particular interest in political and diplomatic history, encompassing the former Soviet Union and East Asia, and in the value of music for children with special educational needs and disabilities.

MATTHIAS RANGE has published widely in both history and music, with the focus of his interdisciplinary research being sacred music and religious culture since the sixteenth century. An area of particular interest is the history of the British monarchy, which is the topic of his major publications. He currently works as a postdoctoral researcher for the Digital Image Archive of Medieval Music at the Faculty of Music, University of Oxford.

PHILIP REED studied at the universities of Leeds and East Anglia. His publications include six volumes of Britten's *Selected Letters* (co-edited with Donald Mitchell and Mervyn Cooke, University of California and Boydell Press, 1991–2013); a Cambridge University Press Opera Handbook on *Billy Budd* (co-edited with Cooke, 1993); an edition of Pears's travel diaries (Boydell Press, 1995), and contributions to *The Cambridge Companion to Benjamin Britten* and to studies of *Death in Venice*, *Gloriana*, *A Midsummer Night's Dream*, *Peter Grimes* and *War Requiem*. He also edited and contributed to *On Mahler and Britten*.

HANNA ROCHLITZ is an independent scholar based in Göttingen, Germany. Her dissertation *Sea-Changes: Melville – Forster – Britten: The Story of Billy Budd and Its Operatic Adaptation* was published by Universitätsverlag Göttingen in 2012, and she contributed a chapter on Forster's and Britten's reading(s) of Melville to the 2018 *Literary Britten* collection. She is now pursuing a career outside academia.

ERIC SAYLOR is Professor of Music History at Drake University. He is the co-editor of *Blackness in Opera* (with Naomi André and Karen M. Bryan, University of Illinois Press, 2012), and *The Sea in the British Musical Imagination* (with Christopher M. Scheer, Boydell Press, 2015). He has also written *English Pastoral Music: From Arcadia to Utopia*, 1900–1955 (University of Illinois Press, 2017) and *Vaughan Williams* (Oxford University Press, 2022) for the Master Musicians series.

CHRISTOPHER M. SCHEER is Associate Professor of Musicology at Utah State University in Logan. Scheer's contributions to British music studies, and the music of Gustav Holst, Arthur Sullivan, John Foulds, and Benjamin Britten, can be found in books published by Brepols, Ashgate, and Boydell, as well as in articles in *The Journal of Victorian Culture* and *The Journal of Musicological Research*. He also recently edited a collection of essays, with Dr Eric Saylor, on *The Sea and the British Imagination* (Boydell Press, 2015).

THOMAS SCHUTTENHELM is a composer, guitarist, and scholar. Complementing his role as the Artistic Director at Network for New Music, his research interests are focused on contemporary music. For her writing, she has been awarded the ASCAP Deems Taylor/Virgil Thomson award, the Westrup Prize, and the Ruth Solie Prize.
