INTERNATIONAL LAW AND THE COLD WAR

International Law and the Cold War is the first book to examine the relationship between the Cold War and International Law. The authors adopt a variety of creative approaches – in relation to events and fields such as nuclear war, environmental protection, the Suez crisis and the Lumumba assassination – in order to demonstrate the many ways in which international law acted upon the Cold War and in turn show how contemporary international law is an inheritance of the Cold War. Their innovative research traces the connections between the Cold War and contemporary legal constructions of the nation-state, the environment, the third world and the refugee; and between law, technology, science, history, literature, art and politics.

MATTHEW CRAVEN is a Professor of International Law at SOAS University of London, and Chair of the Centre for the Study of Colonialism, Empire and International Law. He is also a Senior Fellow at Melbourne Law School and a member of the Advisory Council for the Institute for Global Law and Policy at Harvard Law School. He is author of *The Decolonization of International Law: State Succession and the Law of Treaties* (2007) and *The International Covenant on Economic, Social and Cultural Rights* (1995).

SUNDHYA PAHUJA is a Professor of International Law and Director of the Institute for International Law and the Humanities at the University of Melbourne. She is a leading scholar of postcolonial international law, and author of *Decolonising International Law* (Cambridge, 2011).

GERRY SIMPSON is a Professor of International Law at the London School of Economics and Political Science. He held the Sir Kenneth Bailey Chair of Law at the University of Melbourne Law School. He is the author of *Great Powers and Outlaw States* (Cambridge, 2004) and *Law, War and Crime: War Crimes Trials and the Reinvention of International Law* (2007).
