The fourth edition of *Australian Intellectual Property Law* provides a detailed and comprehensive, yet concise and accessible, discussion of intellectual property law in Australia. It has been thoroughly revised to cover the most recent developments in intellectual property law, including significant case law and the proposed and enacted amendments to the *Copyright Act 1968* (Cth), the *Patents Act 1990* (Cth) and the *Plant Breeder's Rights Act 1994* (Cth) made in response to the recommendations of the 2016 Productivity Commission inquiry report *Intellectual Property Arrangements*

The new edition provides a comprehensive discussion of the black-letter aspects of the law with its primary emphasis on legal principles and complexities. The content has been restructured for clarity and accessibility: the book now commences with copyright and related regimes such as protection for performers' rights and circuit layouts, followed by design law, confidential information, patents, plant breeder's rights, and finally trademarks and passing off. The final chapter covers general aspects of enforcement of legal rights and civil remedies that are particularly pertinent to intellectual property.

Written by highly respected intellectual property law researchers, *Australian Intellectual Property Law* is an invaluable resource for both undergraduate and postgraduate students, academics and other professionals working with intellectual property.
