

Protestant Empires

Protestantism during the early modern period is still predominantly presented as a European story. Advancing a novel framework to understand the nature and impact of the Protestant Reformations, this volume brings together leading scholars to integrate global Protestant experiences into accounts of the early modern world created by the Reformations. It seeks to compare Protestant concepts and practices with other world religions, to chart colonial politics and encounters, and to ask how resulting ideas and identities were negotiated by Europeans at the time. Through its wide geographical and chronological scope, *Protestant Empires* advances a new way of understanding the Protestant Reformations. Showcasing selective model approaches on how to think anew and pointing the way towards multi-national and connected accounts of the period, this volume demonstrates how global interactions and their effect on Europe have played a crucial role in the history of the “long Reformation” in the seventeenth and eighteenth centuries.

ULINKA RUBLACK is Professor of European History at the University of Cambridge. She is the author of *Reformation Europe* (2nd revised edition, 2017), and editor of *The Oxford Handbook of the Protestant Reformations* (2016) and *The Concise Companion to History* (2011).

SUSANNA BURGHARTZ is Professor of Renaissance and Early Modern History at the University of Basel. She has published widely on early modern gender and sexuality, Reformation and confessionalization, material culture, and early globalization. RENATE DÜRR is Professor of Early Modern History at the University of Tübingen. She has written on Lutheran church spaces as contested spaces in the early modern period for her habilitation. In the past few years she has worked on Jesuit missions, on cultural as well as linguistic translations in these contact zones, and on the connection between the Society of Jesus and Enlightenment. Recently, she has started to look into the global dimensions of early modern German history. Her analysis of Lutheran baptismal sermons concerning Muslim prisoners of war and African slaves is part of this new research interest.

ULRIKE GLEIXNER is Head of the Research Department at the Herzog August Library in Wolfenbüttel, Germany, and is Professor of Early Modern History at the Technical University Berlin/Zentrum für Interdisziplinäre Frauen- und Geschlechterforschung. Her research fields include the cultural history of religion, especially Pietism; autobiographical writings; the gender history of knowledge and memory culture; the materiality of books. She is currently working on a book with the working title *The Pietist Empire in India. Millenarian Practices and the German supporter network*.

ANTHONY GRAFTON is Henry Putnam University Professor of History at Princeton University. He is the author of ten monographs that focus on major Renaissance intellectual figures and knowledge practices, and the co-author, editor, co-editor, or translator of nine other books, including *Defenders of the Text* (1991) and *Bring Out Your Dead* (2001). He has been the recipient of the Balzan Prize for History of Humanities (2002), and the Mellon Foundation's Distinguished Achievement Award (2003). Professor Grafton is currently finishing a monograph on the science of chronology.

DAVID D. HALL is Bartlett Professor, emeritus, Harvard Divinity School. He has written widely on religion and culture in early New England and, more recently, on early modern Britain. His books include *The Puritans: A Transatlantic History* (2019); *A Reforming People: Puritanism and the Transformation of Public Life in Early New England* (2011); and *Worlds of Wonder, Days of Judgment Popular Religion in Seventeenth-Century New England* (1989).

NEIL KAMIL is an associate professor in the department of History at the University of Texas at Austin. He is the author of *Fortress of the Soul: Violence, Metaphysics, and Material Life in the Huguenots' New World, 1517–1751* (2005).

CHARLES H. PARKER is Professor of History at Saint Louis University. His research interests focus on the religious and cultural history of early modern Europe and interactions in world history. He is currently finishing a book on Calvinism and empire in the early modern world entitled *Global Calvinism: Conversion and Commerce in the Dutch Empire*.

CARLA GARDINA Pestana, the Joyce Appleby Endowed Chair of America in the World at UCLA, researches religion and empire in the English Atlantic context. She is the author, most recently, of the *English Conquest of Jamaica: Oliver Crowell's Bid for Empire* (2017), as well as of *Protestant Empire: Religion and the Making of the British Atlantic World* (2009). Harvard University/Belknap Press will publish *The World of Plymouth Plantation* in 2020.

ULINKA RUBLACK is Professor of European History at Cambridge University. Her books include *Reformation Europe* (2nd expanded ed. 2017, Cambridge University Press), and, as editor, *The Oxford Handbook of the Protestant Reformations* (2016), as well as *The Concise Companion to History* (Oxford University Press, 2011).

JON SENSBACH teaches early American and Atlantic history at the University of Florida. He is the author of *A Separate Canaan: The*

MERRY WIESNER-HANKS is Distinguished Professor of History and Women's and Gender Studies, emerita, at the University of Wisconsin-Milwaukee. She is the long-time senior editor of the *Sixteenth Century Journal*, and the editor-in-chief of the seven-volume *Cambridge World History* (2015).
