# Preface

This book aims to provide an easy-to-read foundation for any health care professional engaged in primary health care practice in the community.

Part I introduces the key concepts that underpin primary health care nursing practice. The objective is to provide a basic understanding of these concepts to enable students to explore the associated theory in depth; to provide a fundamental understanding that is so often assumed, rather than built.

The second part of the text provides information relating to skills used in community and primary health care practice. This information is discussed at a beginning practitioner level, with a view to being used as a launch pad for future practice.

The final part of the text uses a number of community and primary health care nursing roles to enable students to explore the numerous opportunities and diverse ways in which the concepts discussed in Parts I and II are implemented in daily practice. Although this section focuses on nursing practice, many of these roles occur within interdisciplinary teams, and therefore it provides similar insights for students from other health care disciplines. It is important to keep in mind that the wide selection of roles and titles presented may vary across and within the states and territories. The purpose of this section of the text is to demonstrate the links between theory and practice. One of the most exciting aspects of working in community and primary health care settings is that it offers many unique and eclectic practice possibilities to meet the diverse needs of individuals, their families and communities.
