Convening leading scholars to reflect on the practical and philosophical implications of religious values, this volume is an accessible introduction to Catholic social thought on contemporary affairs. Its gracefully written chapters cover three themes – direct environmental policy implications of *Laudato Si'*, philosophical alternatives to dominant policy discourse, and a renewed political economy based on robust conceptions of human flourishing. *Care for the World* offers learned reflections on what it would mean to express an ethic of compassion in an era of climate crisis.

Frank Pasquale is Professor of Law at the University of Maryland, and author of *The Black Box Society* (2015). He is an expert on the law of artificial intelligence and algorithms. He has been published in *Commonweal*, and his scholarly work has explored the implications of Catholic social thought for innovation policy.

Acknowledgments

I first wish to thank Lawrence Joseph for suggesting the idea of this collection to me. I have benefitted from his stunningly eloquent poetry and his keen insights on politics, policy, and law. His intellect, and his capacity for hope (despite a remarkably clear-eyed grasp of the brokenness of the world), is rooted in a deep appreciation of the transcendent. That sensibility was an inspiration for me as I assembled and edited this collection.

As the collection took shape, Michael Perry offered sage advice and encouragement. John Witte has been a supportive series editor. The anonymous reviewers of the essays in this volume were both expert and encouraging, helping us to shape a more coherent set of statements on the enduring importance of *Laudato Si'*.

On a more personal note, I should acknowledge those who played a role in my own faith formation. The Catholic Church deeply shaped my parents' sense of life's ultimate meaning and purpose, and they in turn shaped mine. I acknowledge the great good fortune to have seen, in them, two of the many cultural styles of the faith: a demanding and metaphysical expression often found in Northern Europe, and the *joie de vivre* of Mediterranean Catholicism. In these two very different styles, they modeled for me the ways in which faith can both lend gravity to, and lighten the burden of, our journey through this world. They also did the hard work of getting me to First Communion and confirmation classes, and paying for my Catholic schooling when they could afford it. The Church, in turn, was a rare fixed point of stability in their lives, which were too often upended by what business gurus and neoliberal economists would approvingly deem "disruption" and "labor market mobility."

Catholic primary school in Kentucky and Oklahoma offered yet another experience of faith formation, and I thank all the teachers there (including especially Ruella Yates) for the discipline they imposed and the creativity they inspired.

At Harvard and Yale, I found several brilliant scholars who blended faith and reason. Father Bryan Hehir, despite so many academic and other obligations, was generous with his time with the Harvard Catholic Students Association, showing us the rigor of theology – as did Chaplain Jacqui Landry, who was an exceptionally

warm and welcoming presence. Father Bob Beloin at Yale promoted "small church communities" that fostered genuine friendship and bible study among his congregants. Learned women and men at each institution helped me to "keep the faith" despite the many challenges to it raised by my reading in social theory.

While I taught at Seton Hall University (named after Saint Elizabeth Ann Seton), I was blessed to have many colleagues whose wisdom and learning reflected their faith. Father Nicholas Gengaro graced our community with homilies at weekday masses that reflected a deep appreciation of the relevance of scripture and Catholic social teaching to our daily lives, and our community. The faculty also exuded an inclusive ecumenism, with colleagues of all faiths (and none) comfortable discussing ultimate issues in wide-ranging and learned conversations. I wrote a tribute to one of them, Marc Poirier, when he passed away, and I still miss his work to bring opportunities for spiritual practice (in his case, grounded in Buddhist meditation) to a wider community.¹

My friends Cat, Luanne, Mark, and Chris continue to exemplify both grace and theological learning for me, freely sharing their wide reading and experiences of worship and prayer. They are also inspirations.

For all that it has done for me and my community, any honest acknowledgment section for a book like this must also confront the fact that the Catholic Church is far from perfect, and itself has fallen short in many ways in my lifetime (and certainly before as well). For giving me the hope and faith that positive evolution in practice and doctrine is possible today, I thank public intellectuals like Father James Martin. And I thank them also for bringing the good news of the faith to political disputes over gun control and immigration policy. I also thank the Jesuits at "Pray as You Go" for helping to bring contact with Jesus into the lives of me and so many other Catholics. When this project or other research was trying, I found myself centered and at piece when listening to their digital breviary.

Finally, my thanks to the many dedicated people at Cambridge University Press who have helped to bring this book into being. It is an honor to be part of the Law and Christianity series.
