

## The Development Century

This anthology offers a cutting-edge perspective on how development has shaped the history of the modern world. Stephen J. Macekura and Erez Manela have gathered together leading historians to examine development on the international, regional, and national levels as well as local manifestations of development initiatives and transnational organizing on behalf of alternative approaches. Themes include the relationship between empire and development, the role of international organizations, the influence of the Cold War, decolonization and postcolonial development strategies, reform and resistance to development, development and global health, and the ecological effects of development. *The Development Century* examines how ideas and discourses about development have shaped its practices on the ground; explores the ways in which policymakers and experts attempted to implement development through specific institutions and policies; and analyzes development initiatives and their effect on local environments and people.

Stephen J. Macekura is Assistant Professor of International Studies at Indiana University, Bloomington. He is the author of *Of Limits and Growth: The Rise of Global Sustainable Development in the Twentieth Century* (Cambridge, 2015).

Erez Manela is Professor of History at Harvard University, where he also serves as Director of Graduate Programs at the Weatherhead Center for International Affairs and co-chairs the Harvard International and Global History Seminar (HIGHS). He is the author of the prize-winning book *The Wilsonian Moment: Self-Determination and the International Origins of Anticolonial Nationalism* (2007) and co-editor of *The Shock of the Global: The 1970s in Perspective* (2010) and *Empires at War, 1911–23* (2014).

He is the author or editor of two books: *Writings on War* (2011), a compendium of Carl Schmitt's interwar writings on international order, and *Humanitarian Invasion: Global Development in Cold War Afghanistan* (2016). His present project, *The Islamic Factor: Socialists, Islamists and the Soviet Union in Cold War Eurasia*, examines the clash between the international Islamist movement and the international socialist movement in the twentieth century.

**Thomas Robertson** researches the environmental history of international development. His works include *The Malthusian Moment: Global Population Growth and the Birth of American Environmentalism* (2012); *Cold War Landscapes: Toward an Environmental History of U.S. Development Programs in the 1950s and 1960s*, *Cold War History* (2016); and, co-edited with Jenny Leigh Smith, *Transplanting Modernity: New Histories of Technology, Development, and Environment* (forthcoming). Trained at the University of Wisconsin-Madison, he currently directs the Fulbright office in Kathmandu, Nepal.

**Cyrus Schayegh** (PhD, Columbia University, 2004) was Associate Professor at Princeton before joining the Graduate Institute, Geneva, in 2017. His books include *The Middle East and the Making of the Modern World* (2017) and *The Routledge History Handbook of the Middle East Mandates* (2015), and he has published in *The American Historical Review*, *Comparative Studies in Society and History*, and *Geschichte und Gesellschaft*, among other journals. His current research projects focus on the interplay between globalization and decolonization after World War II, interwar European inter-imperial cooperation, historiography, and Arab views of Afro-Asian decolonization.
