

## At the Margins of the Global Market

Contemporary scholars debate the factors driving despotic labor conditions across the world economy. Some emphasize the dominance of global market imperatives; others highlight the market's reliance on extra-economic coercion and state violence. *At the Margins of the Global Market* engages in this debate through a comparative and world-historical analysis of the labor regimes of three global commodity-producing sub-regions of rural Colombia: the coffee region of Viejo Caldas, the banana region of Urabá, and the coca/cocaine region of the Caguán. Drawing on insights from labor regimes, global commodity chains, and world historical sociology, this book offers a novel understanding of the broad range of factors – local, national, global, and interregional – that shape labor conditions on the ground in Colombia. In doing so, it offers a critical new framework for analyzing labor and development dynamics that exist at the margins of the global market.

**Phillip A. Hough** is a Colombian-American sociologist who specializes in political economy, labor and agrarian movements, global commodity studies, comparative and world historical sociology, and Latin American development. His current research focuses on labor/agrarian struggles, state and paramilitary violence, class and state formations, forced displacement, and surplus populations.

## Development Trajectories in Global Value Chains

A feature of the current phase of globalization is the outsourcing of production tasks and services across borders, and the increasing organization of production and trade through global value chains (GVCs), global commodity chains (GCCs), and global production networks (GPNs). With a large and growing literature on GVCs, GCCs, and GPNs, this series is distinguished by its focus on the implications of these new production systems for economic, social, and regional development.

This series publishes a wide range of theoretical, methodological, and empirical works, both research monographs and edited volumes, dealing with crucial issues of transformation in the global economy. How do GVCs change the ways in which lead and supplier firms shape regional and international economies? How do they affect local and regional development trajectories, and what implications do they have for workers and their communities? How is the organization of value chains changing and how are these emerging forms contested as more traditional structures of North–South trade complemented and transformed by emerging South–South lead firms, investments, and trading links? How does the large-scale entry of women into value-chain production impact on gender relations? What opportunities and limits do GVCs create for economic and social upgrading and innovation? In what ways are GVCs changing the nature of work and the role of labor in the global economy? And how might the increasing focus on logistics management, financialization, or social standards and compliance portend important developments in the structure of regional economies?

This series includes contributions from all disciplines and interdisciplinary fields and approaches related to GVC analysis, including GCCs and GPNs, and is particularly focused on theoretically innovative and informed works that are grounded in the empirics of development related to these approaches. Through their focus on changing organizational forms, governance systems, and production relations, volumes in this series contribute to on-going conversations about theories of development and development policy in the contemporary era of globalization.

## Acknowledgments

The initial premises of this book were first explored in my doctoral dissertation at Johns Hopkins University, where I worked under the guidance of Beverly Silver and the late Giovanni Arrighi (1937–2009). Since my arrival at Florida Atlantic University in 2007, I pushed its conceptual framework in new directions, conducted new rounds of fieldwork, regularly updated and reanalyzed my longitudinal datasets on Colombian social protests and political violence, and tried my desperate best to keep up with the flood of secondary literature on the country's coffee, bananas, cattle, and cocaine industries. Until now, my research publications have only reflected small fragments of this work. It was through the writing of this book, however, that I have been able to pull the various strands of my research on Colombian labor regimes into one thread.

Like all books whose preparation spans such a long period of time, it would not have been possible without the help of numerous individuals and institutions. Funding for my fieldwork and data was made possible by a Fulbright scholarship (2003–4) and multiple FAU Morrow Fund Research Grants (2009, 2013, 2015). A fellowship from the American Council of Learned Societies (ACLS) in addition to a full-year sabbatical in (2018–19) gave me the time I needed to write a full first draft of the manuscript. Special thanks to Lesley Gill and Roberto Patricio Korzeniewicz for supporting my ACLS fellowship and to Ann Branaman, Cathy King, and Aimee Kanner Arias for working out the logistics of my sabbatical. I would also like to thank Beverly Silver, Marta Petrusiewicz, and Fortunata Piselli for organizing the “Capitalist Development in Hostile Environments” conference at the University of Calabria, Italy, in 2017, as well as Liam Campling and the editors of the *Journal of Agrarian Change* (JAC), who published a special issue on Arrighian agrarian political economy in 2019. The Calabria conference gave me an opportunity to test out some of the central claims of this book with some of the sharpest scholars of historical capitalism. The special issue of JAC (coedited with Jennifer Bair and Kevan Harris), which developed from conversations in Calabria, in turn, helped connect my ideas to contemporary debates in the field of agrarian political economy.

While conducting fieldwork in Colombia, I incurred countless debts to individuals who graciously offered hours of their time for interviews, field visits, and

explanations of local institutions and practices. A full list of the activists, journalists, independent researchers, academics, government officials, industry representatives, and others who assisted me during this project would be exceedingly long. A few, however, went above and beyond and deserve special thanks.
