

SACRED MODES OF BEING IN A POSTSECULAR WORLD

How do we talk meaningfully about the sacred in contexts where conventional religious expression has so often lost its power? Inspired by the influential work of David Jasper, this important volume builds on his thinking to identify sacrality in a world where the old religious and secular debates have exhausted themselves and theology struggles for a new language in their wake. Distinguished writers explore here the idea of the sacred as one that exists, paradoxically, in a space that is both possible and impossible: profoundly theological on the one hand, but also deeply this-worldly and irreligious on the other. This is a sacredness that is simultaneously 'present' and 'absent': one which encompasses — as Jasper himself characterises it — 'the impossible possibility of an absolute vision'. The book teaches us that the sacred assumes a renewed potency when fully engaged with the creativity that happens across religion, literature, philosophy and the arts.

ANDREW W. HASS is Reader in Religion at the University of Stirling. He works at the intersections of religion, theology, philosophy, art and hermeneutics. He is General Secretary of the International Society of Religion, Literature and Culture, and is a founding member of Critical Religion Association. For many years he held the role of Executive Editor of the journal *Literature and Theology*. His books include *Auden's O* and *Hegel and the Art of Negation*.

Contributors

THOMAS J. J. ALTIZER (1927–2018) was a leading figure in what has been called the Death of God controversy. Author of more than a dozen books since the early 1960s, he wrote with a singular focus on the manifestations of God's death within Western culture. He held academic positions at Wabash College and Emory University before joining the English department at the State University of New York at Stony Brook in 1968. In 1970 he also became chairman of a new interdisciplinary unit in religious studies at Stony Brook. Upon his retirement in 1996, Altizer remained active as a distinguished theological thinker and intellectual mentor to emerging scholars in theology and religious studies.

MIEKE BAL is a cultural theorist, critic, video artist and occasional curator. She works in cultural analysis, literature and art, focusing on gender, migratory culture, psychoanalysis and the critique of capitalism. Her 44 books include a trilogy on political art. Her video project, *Madame B*, with Michelle Williams Gamaker, is widely exhibited, and in 2017 was combined with paintings by Edvard Munch in the Munch Museum in Oslo. PAUL S. FIDDES is Professor of Systematic Theology in the Faculty of Theology and Religion at the University of Oxford, and Senior Research Fellow at Regent's Park College, Oxford, where he was Principal from 1989 to 2007. He has been Chairman of the Board of the Faculty of Theology is a Fellow of the British Academy, and Religion, and is an Honorary Fellow of St Peter's College, Oxford. Author of numerous books, including Seeing the World and Knowing God: Hebrew Wisdom and Christian Doctrine in a Late-Modern Context (Oxford University Press, 2013) and a first novel,

A Unicorn Dies: A Novel of Mystery and Ideas (Cascade, 2019), his research interests lie in the doctrine of the Triune God, wisdom literature, the relations between theology, literature and late-modern philosophy, and ecumenical ecclesiology.

ANDREW W. HASS is Reader in Religion at the University of Stirling. His interests and publications operate at the intersection of religion, philosophy, theology, literature and art, with particular interest in the idea of nothing (*Auden's O: The Loss of One's Sovereignty in the Making of Nothing,* SUNY Press, 2013) and German Idealism (*Hegel and the Art of Negation,* I. B. Tauris, 2014). His current projects focus on music, Spirit and silence. He is General Secretary of The International Society for Religion, Literature and Culture, and served for over ten years as the Executive General Editor of the journal *Literature and Theology: An International Journal of Religion, Theory and Culture* (Oxford University Press).

DAVID JASPER was Professor of Literature and Theology at the University of Glasgow until his retirement in 2017. He holds degrees from Cambridge, Oxford, Durham and Uppsala universities and has taught for many years as Visiting Professor in Renmin University of China, Beijing. He works in the interdisciplinary fields of theology, literature, art, hermeneutics and theory. He founded the Conference on Literature and Religion at Durham University in 1980, which later became the International Society of Religion, Literature and Culture, and which spawned the journal *Literature and Theology: An International Journal of Religion, Theory and Culture* (Oxford University Press), of which he was the first Editor. His many publications mark him a leader in the field of religion and literature, his most recent books being *The Language of Liturgy: A Ritual Poetics* (SCM Press, 2018) and *Literature and Religion: A Dialogue between China and the West* (Pickwick Publications, 2020).

WERNER G. JEANROND is Professor of Systematic Theology at the University of Oslo, Norway. He has held posts in the universities of Dublin, Lund, Glasgow and Oxford. His research interests are in the areas of systematic theology, theological and philosophical hermeneutics, theological method, theology of religions, theology of love, theology of hope and political theology. His many published texts include *Reasons to Hope* (T&T Clark, 2020), *A Theology of Love* (T&T Clark, 2010) and *Theological Hermeneutics: Development and Significance* (Macmillan, 1991 and SCM Press, 1994).

MATTIAS MARTINSON is full Professor of Systematic Theology and Studies in Worldviews at Uppsala University, Sweden. CHRISTOPHER ROWLAND is a British Anglican priest, theologian and academic, having been Dean Ireland's Professor of the Exegesis of Holy Scripture at the University of Oxford from 1991 to 2014. His research focuses on interpretation of the New Testament, the apocalyptic tradition in ancient Judaism and Christianity, the reception history of the Apocalypse, the biblical hermeneutics of William Blake, the theology of liberation, the radical tradition in Christianity, methods in grassroots readings of Scripture, group work and biblical study, and the interpretation of the Bible and developments in adult education. He is co-editor of the Blackwell Bible Commentaries which focus on reception history. The most recent of his many publications is *Radical Prophet: The Mystics, Subversives and Visionaries Who Strove for Heaven on Earth* (I. B. Tauris, 2017).

GRAHAM WARD is Regius Professor of Divinity at Christ Church and canon of Christ Church Cathedral at the University of Oxford. His broad research encompasses theology, philosophy and cultural studies, with wider interests in the nature of religion and its relationship to anthropology, sociology, politics, gender theory and contemporary science. He has published widely on these various topics, with current projects that include a three-volume work developing a culturally engaged systematic theology.
