

TRUSTS AND PRIVATE WEALTH MANAGEMENT

There has been insufficient literature focusing on the world-changing rise of Asian wealth. Private wealth in Asia is very substantial, with 33 per cent of the global population of high-net-worth individuals based in Asia. Yet, there is a dearth of legal analysis of Asian wealth, particularly by texts written in English. This collection aims to fill that gap, with chapters on legal issues in relation to Asian wealth transmission, investments in international real estate, familial disputes, family offices, and private trust companies. A substantive section of this book also focuses on the changing legal context with chapters exploring trusts and cryptoassets, constructive trust, trustee's discretion and decision-making, changing regulatory environment, and abuse of trust structures. This collection of essays on trusts and wealth management presents a focus on Asian wealth and the changing legal context, and follows the related publication, *Trusts and Modern Wealth Management* (Cambridge University Press, 2018).

Richard C. Nolan is Professor of Law at the University of York and previously Reader in Corporate and Trust Law at the University of Cambridge. His work has been cited by judges in the United Kingdom, Australia, Singapore, New Zealand, and Hong Kong. He has been a consultant to several governmental bodies.

Tang Hang Wu is Professor at the Yong Pung How School of Law, Singapore Management University, researching on equity, trusts, and wealth management. Hang Wu has published widely and advised local and international law firms, high-net-worth individuals, US Department of Justice, and banks and trust companies on trust law.

Man Yip is Associate Professor at the Yong Pung How School of Law, Singapore Management University, researching on equity, trusts, remedies, and private international law. She has published widely in international peer-reviewed journals and her work has been cited in leading treatises and courts.

Contributors

The Right Hon Lady Arden of Heswall DBE grew up in Liverpool and read law at Girton College Cambridge and Harvard Law School. Called to the Bar in 1971, she became a Queen's Counsel in 1986 and served as Attorney General of the Duchy of Lancaster between 1991 and 1993. Her judicial career began in 1993 when she was appointed to the High Court of Justice of England and Wales, as the first woman judge assigned to the Chancery Division. Between 1996 and 1999 she served as Chairman of the Law Commission of England and Wales. She was a justice of the Court of Appeal of England and Wales from 2000 to 2018. On 1 October 2018 she became Justice of the Supreme Court of the United Kingdom. She retired on 24 January 2022. Lady Arden has also served as the Member of the Permanent Court of Arbitration in The Hague and as an *ad hoc* UK judge of the European Court of Human Rights.

Tobias Barkley is a lecturer at the La Trobe Law School, La Trobe University, Australia. His research interests are the doctrinal foundations and social impact of contemporary trust practice, with a focus on discretionary trusts. Tobias has published a range of articles on issues in trust law, and his work has been presented before the New Zealand Supreme Court.

Chan Ee Lin is an internationally recognised trust and wealth planner and family business governance advisor to high net worth families in Asia. Director and SE Asia lead for Family Enterprise Consulting at Deloitte Tax Services, Ee Lin is also a top-rated adjunct professor of executive education and masters programs at Nanyang Technological University and Singapore Management University. Her research led to the setting up of the Special Needs Trust Scheme by the Hong Kong Government.

Rebecca Lee is an Associate Professor at the Faculty of Law, The University of Hong Kong. Vincent's books include *Singapore Trusts Law* and both tax law volumes of *Halsbury's Laws of Singapore*. He was previously Deputy Head of Tax at a Singapore law firm, Law Supervisor at Peterhouse College, Cambridge, and has held research positions at all three law schools in Singapore.
