

JUSTICE

Claims about a pursuit of justice weave through all periods of China's modern history. But what do authorities mean when they refer to 'justice', and do Chinese citizens interpret justice in the same way as their leaders? This book explores how certain ideas about justice have come to be dominant in Chinese polity and society and how some conceptions of justice have been rendered more powerful and legitimate than others. This book's focus on 'how' justice works, incorporates a concern about the processes that lead to the making, un-making and re-making of distinct conceptions of justice. Investigating the processes and frameworks through which certain ideas about justice have come to the political and social forefront in China today, this innovative work explains how these ideas are articulated through spoken performances and written expression by both the party-state and its citizenry.

FLORA SAPIO is a Visiting Fellow at the Australian Centre on China in the World at the Australian National University. Her research interests are diverse and include globalisation, ideology and contemporary Chinese legal philosophy, Chinese criminal justice, and civil society organisations in China, among others; her publications include *Sovereign Power and the Law in China* (2010).

SUSAN TREVASKES is a member of the Griffith Criminology Institute at Griffith University and is an Adjunct Director of the Australian Centre on China in the World at the Australian National University. Her sole-authored works include *The Death Penalty in Contemporary China* (2012). She has published widely in journals such as *The British Journal of Criminology, The China Journal* and *The China Quarterly*.

SARAH BIDDULPH is an Australian Research Council Future Fellow (2014–2018) and a Professor of Law at the Melbourne Law School. Her recent publications include: *The Stability Imperative: Human Rights and Law in China* (2015)
