Key Conflicts of Classical Antiquity

This series is aimed at introductory level undergraduates who have no background in ancient history and no experience in dealing with primary texts. Each volume in the series will focus on a key conflict of antiquity. It will provide a basic narrative of the event – who, when, what; a critical overview of the textual and material sources for the conflict – how we know what we know; the consequences of the conflict – why we study it; and an account of the reception of the conflict in classical antiquity and beyond. The aim is to provide students with foundation before they read the relevant primary sources; and to enable the instructor to focus on problems and issues in class time, rather than rehearsing names and dates.

Key Conflicts of Classical Antiquity

Rome's Gothic Wars from the Third Century to Alaric

Rome's Gothic Wars from the Third Century to Alaric is a concise introduction to the latest research on the Roman Empire's relations with one of the most important barbarian groups of the ancient world. It uses archaeological and historical evidence to look not just at the course of events, but at the social and political causes of conflict between the empire and its Gothic neighbours. In eight chapters it traces the history of Romano-Gothic relations from their earliest stage in the third century, through to the development of strong Gothic politics in the early fourth century, until the entry of many Goths into the empire in 376 and the catastrophic Gothic war that followed. It closes with a detailed look at the career of Alaric, the powerful Gothic general who sacked the city of Rome in 410. Students will find this a reliable survey of both Gothic and Roman history that explains why we know what we know, while ancient and medieval historians can use it as a first introduction to the many interpretative controversies that surround the history of the barbarians.

This textbook examines the daily lives of Roman women by focusing on the mundane and less celebrated aspects of daily life – family and household, work and leisure, worship and social obligations – of women of different social ranks. Using a variety of sources, including literary texts, letters, inscriptions, coins, tableware, furniture, and the fine arts, from the late Republic to the high Imperial period, Eve D'Ambra shows how these sources serve as objects of social analysis, rather than simply as documents that recreate how life was lived. She also demonstrates how texts and material objects take part in shaping realities and what they can tell us about the texture of lives and social attitudes, if not emotions of women in Roman antiquity.
